The Request for Proposal (RFP) Amendment 001 is raised to answer Bidders questions and amend the RFP.

QUESTIONS AND ANSWERS

Question 1

The Corporate Mandatory Criteria M3, requires companies to hold an ISO certification in order to bid. This is restricting the list of potential bidders to a small group of large organizations and eliminating local companies. Please consider removing this criterion entirely, or asking for ISO certification OR the bidders' "Corporate Quality Assurance Program". Alternatively, please make this Rated Criterion for 5 points, as opposed to a mandatory criterion.

Question 2

In regards to M3, if a firm submits in it's a bid letter of commitment to indicate that the ISO certification process has been initiated and will be completed within 90 days of bid closing will the Crown deem this compliant. This would allow firms that are not currently certified the ability to do so.

Question 3

M3: *The bidder must demonstrate it holds a current and valid ISO 9001 certification.*

Note: *Copies of the certification should be enclosed with the bid.*

Only a select number of firms have this certification, and this would limit the number of submissions received.

Additionally, would the Crown accept in the place of M3, a detailed write-up on firms internal quality control measurements (background checks, reference checks, etc.)
