Questions and Answers

Q1. Can PSPC recommend resources for identifying QP-PFAS?

A1. PSPC cannot recommend specific QP-PFAS. However, proponents are encouraged to look among the PFAS-specific technical contributors to conferences or symposiums (e.g. RPIC 2019 Halifax, SERDP/ESTCP Symposiums, Dioxin 20XX, Fluoros 2015), regulatory working groups (e.g. ITRC PFAS working group), or peer-reviewed literature (e.g. PFAS-related articles in journals such as Environmental Science & Technology) to assist their identification of a suitable candidate for the role. Note that, unlike the QP definition in the specifications, the QP-PFAS definition does not include the jurisdictional requirement. Provided that the QP-PFAS meets all of the listed criteria, they are not required to be accredited in BC.

Q2. Can the requirements for the PFAS QP be adjusted to a minimum 5 years of contaminated soil incineration experience coupled with a minimum 2 years as a technical lead on PFAS contamination projects?

A2. No, the requirements for the QP-PFAS cannot be adjusted. It is expected that at least five years of experience as a technical lead on PFAS contamination projects is necessary to support a technically sound evaluation of the work required under this Contract.

Q3. Concerning the PFAS impacted soils that meet the criteria for stabilization and reuse on the site (Base work A-Tender Item 17, Optional work B- Item 8)?, can you please clarify if it is possible to treat these soils in place?

A3. PFAS stabilization must be conducted on site and ex-situ (i.e. after excavation and segregation) to facilitate payment by weight in accordance with the specifications. After excavation and segregation, stabilization could be conducted either within the excavation footprint or in the contractor laydown or stockpile areas assuming appropriate environmental protections are in place and DR approval.

Q4. If in place soil stabilization is not allowed at the site, does an offsite facility intended for stabilization need to be permitted for handling PFAS? What are the other specific requirements for a proposed soil stabilization facility? (Base work A-Tender Item 17, Optional work (B)- Item 8)?

A4. Off site stabilization is not allowed.

Q5. Can you please confirm on-site work hours? There is a discrepancy in the presentation and the project specification document. During the presentation, the presenter mentioned that on-site work hours are 8:30-17:30, and page 16 of the project specification document states that the working hours are 7:00- 19:00. Can you please confirm which work hours are approved?

A5. The posted tender documents, Specifications, and Drawings take precedence over any information provided during the Bidder's Meeting. The hours of work remain as per Specification Section 01 11 00, 1.13, which state that the working hours are 07:00 to 19:00 Monday to Saturday.

Q6. Is contractor responsible for site access road construction (widening) at little river road (Before Gate A1)?

A6. This work will be performed by others prior to commencement of work on site for this project.

Q7. Can contractor fuel genset and equipment outside project approved time window (7:00-19:00)?

A7. Access to the site is dictated by the Commissionaire presence at Gate A during the open, working hours as per Specification Section 01 11 00, 1.13, which state that the working hours are 07:00 to 19:00 Monday to Saturday. Any site activity or access outside of these hours will require submittal of a request and coordination with the Departmental Representative.
