REQUEST FOR QUOTATION AMENDMENT NO. 001

Request for Quotation Amendment no. 001 is raised for the following reason:

- To address questions pertaining to the specifications and solicitation;
- To correct the statement of requirement on page 39; and
- To modify Annex B- List of Deliverables and Prices

Question 1

How long after the closed date will the contract be awarded?

Answer 1

This will depend on if the client chooses to test the winning product. If there is no testing required it should be awarded within 10 business days.

Question 2

How Long after award does pricing need to be held for additional quantity options?

Answer 2

The pricing would need to be held for 1 year after contract award.

Question 3

Is the contract listed as 3 years only to cover the warranty and not hold pricing for 3 years?

Answer 3

Yes the contract period is 3 years to cover the warranty. The pricing must be held for 1 year after contract award.

Question 4

Do you require a Dedicated Peripheral Port (DPP) for secure connection to USB peripherals including two-factor authentication devices such as CAC smart card readers, fingerprint readers and facial recognition? As it is not listed in point A) but referenced in point J&K). See picture below with the DPP Port showing an additional USB connection for this port on the console and target side of the KVM.

Answer 4

Yes, Dedicated Peripheral Port (DPP) or Common Access Card (CAC) is required for this requirement.

Question 5

Do the cables need to be molded together, or can they be shipped as individual pieces? Can the cables be sent in bulk in a separate shipment?

Answer 5

I am not sure what molded cables are. In any case the cables should be one piece packed in a bag (one cable per clear bag). Please do not mold the cables together. They should be in separate bags in one box. The cables can be in one box but shipped at the same time and with the KVM's.

Modification 1

On page 39 of the Solicitation, in Annex A- Statement of Requirement (SOR)

Delete: a) 4 Port KVM (supporting the connections of 4 devices) dual head (two DVI-I connected monitors) with integrated cabling for Video (DVI-I), keyboard, mouse and audio

Replace with: a) 4 Port KVM (supporting the connections of 4 devices) dual head (two DVI-I connected monitors) with integrated cabling for Video (DVI-I), keyboard, mouse and audio and CAC support.

Modification 2

On page 39 of the Solicitation, in Annex A- Statement of Requirement (SOR)

DELETE: n) Must include all necessary cables to connect four devices & CAC devices (Dongles will not be accepted)

Replace with: n) Must include all necessary cables to connect four devices & CAC devices (Dongles will not be accepted). Cable length must be a minimum 6 feet

Modification 3

At attachment RFQ 2BH076408/A - Annex B List of Deliverables and Prices EN (with options)

Delete in its entirety and replace with:

AMD 001 RFQ 2BH076408/A - Annex B List of Deliverables and Prices EN (with options)

Reason: Deleted Line items 1, 3, 5 as they are bundled with the 4-Port Secure KVM Switches
