Question 2:

"At the time of submitting this question (Jan 18th) Canada still has not responded to a number of other important questions that we have posed related to how and if specific references can be used. These answers are required in order to build our pre-submission bid package which currently has a deadline of Jan 22nd. In addition, during the bidders briefing session, on Jan 8th, Canada committed to posting new forms (in excel format or other) that would make it easier for bidders to enter in the data required. These forms have yet to be posted and thus has slowed down our ability to collect the reference information required. Also with the bid being released on Dec 21st, just prior to the vacation period, has made it extremely difficult to mobilize our resources, until the new year, to begin the process of analyzing the requirements of this ITQ. The reference data being requested (especially if a bidder is interested in qualifying for more than one stream) is extremely onerous and we require more time to collect and document the reference information being requested.

With this in mind will Canada provide a two week extension to the Jan 22nd pre-bid deadline and a four week extension to the final ITQ? This is a very important solicitation for Canada and we strongly believe that these extensions will allow industry the time necessary to put forward not only the references being requested but also to optimize the partnership models/bidding entity that will be put forward for GCNS. We greatly appreciate Canada's consideration of this request for an extension."

"In Annex C Requirement 6 it states "The Respondent must have provided, as the Prime Contractor, a wireless Local Area Network Service to 5 customers with a minimum of 10 sites with a cumulative total of 500 active users for a period of at least 24 continuous months (which can include the implementation phase) in the last 5 years prior to the closing date of this ITQ",

Please clarify that the customer reference put forward must be receiving a wireless LAN service from the respondent at a minimum of 10 separate physical addresses in Canada. The cumulative total of active users across all 10 + addresses must equal or exceed 500 users (or on average 50 users per site if exactly 10 addresses are put forward)."

The Respondent must have provided, as the Prime Contractor, a wired Local Area Network Service to one customer with a minimum of 10 **unique Customer** sites with a cumulative total of 500 users **(across all Customer Sites for all customers)** for a period of at least 24 continuous months (which can include the implementation phase) in the last 5 years prior to the closing date of this ITQ.

Question 5:

"Would appreciate if Canada could answer the question below. Note: Many of the questions, we have posed, are time-sensitive. Canada has yet to answer a single question and this makes it extremely difficult for us to respond with the reference detail required. Would greatly appreciate an expeditious response.

The current deadline for Q&A remains for Tuesday Jan 26th. As per Amendment #1 Canada has extended the pre-bid submission package and the final ITQ submission by one week. Given the extension to these two key deliverables it would follow that the Q&A deadline would also be pushed one week. Will Canada extend the Q&A deadline by one week to February 2nd 2:00pm."
