Amendment 004 is raised to publish questions and answers:

Q30. The panels on the 4th Floor do not show any panel mounted privacy screens (from cat 1B) as required on the rest of the floors. Was this intentional or are they needed on every floor?

A30. Privacy screens are missing in the CAD but are shown on the issued pdfs and have been included in the RFB counts. See CAD file [a1004-level04-01.dwg](#).

Q31. We received Amendment 3. However, it does not show quantities of each item required in each phase from each category/subcategory.

It only shows the dates of each phase, item # and the floor.

We would like to request for the quantities of each item required in each phase per category/subcategory to ensure the correct quantity is quoted per phase from each category.

A31. No. Canada will not provide the quantities of each item required in each phase per category/subcategory. Please refer to Q/A No.23 at solicitation amendment 003.
