**1) Respond to Vendor Questions:**

**AA) Questions related to Solicitation Document and general questions**

**6.20 FSR Confirmation**

Q. Is it possible to provide the list of FSR representatives and their full contact details, contacts, addresses, phones and email?

A. The FSR representatives where required, are either covered in the Annex A in individual sections along with their contact details or they are big companies which can be located by the bidders on their own for their region. However, if the bidders find that there are FSR details that they are unable to locate or contact on their own, then the bidders are free to ask and Canada will try and locate the contact details for them.

**General:**

Q. Can you confirm that the FSR Quarantine costs will be covered by the quotation allocations?

A. Where FSR allowances are mentioned in Annex A, the allowance can be used to cover the quarantine requirement for the FSR.

Where the allowances are not mentioned for the FSR in Annex A, the bidders will have to include the quarantine costs in the FSR total costs included in their respective bid.

**BB) Questions related to Annex A of Solicitation Document**

Q. See the below information showing the sizes/types of pipe for the spec numbers H-46, H-48, H-50, H51 & H-56 and the linear feet of piping we have been asked to quote as per amendment number 008. Please clarify lengths of each to quote as there are multiple pipe sizes.

AA) At H-46 Fresh Water Cooling Piping Replacement

**Delete (in its entirety):**

### 3.1.6

**Insert:**

**3.1.6** All new piping, fitting and penetration must be supplied by The Contractor and all sizes to be as per original systems. Piping must be Sch 40 seamless steel. The length of new piping to be taken as **total** 600 feet for bidding purpose and the contractor must bid a unit cost per linear ft. **Pipe sizes and lengths: ½" - 100 ft; 1"-100 ft; 1¼"-150 ft; 3"-100 ft; 4"- 150ft.** Any necessary adjustments will be through PSPC 1379 action.

BB) At H-48 Sea Water Piping Replacement

### 3.1.6

**Insert:**

**3.1.6** All new piping, fitting and penetration must be supplied by The Contractor and all sizes to be as per original systems. The length of new piping to be taken as **total** 1000 feet for bidding purpose and the contractor must bid a unit cost per linear ft. Material: 2" and larger is Schedule 40 Seamed galvanized pipe and 1-1/2" and smaller is Schedule 80 Seamed galvanized pipe. **Pipe sizes and lengths: 1½" -175 ft; 2"-125 ft; 2½"-125 ft; 3"-300 ft; 5"- 250ft; 8"-25 ft.** Any necessary adjustments will be through PSPC 1379 action.

CC) At H-50 Grey and Black Water Piping Replacement

H-50 Grey and Black Water Piping Replacement

**3.1.6** The Contractor must replace all grey and black water piping from fixtures located in the accommodations to the point of connection to either the sewage treatment plant or an overboard discharge valve. The length of new piping to be taken as **total** 4000 feet for bidding purpose and the contractor must bid a unit cost per linear ft. **Pipe sizes and lengths: 1¼"-1000 ft; 2"-750 ft; 3"-500 ft; 3½"-250 ft; 4"-500 ft; 5"-500 ft; 6"-500 ft.** Any necessary adjustments will be through PSPC 1379 action.

DD) At H-51 Fuel Piping Replacement

**Insert:**

H-51 Fuel Piping Replacement

**3.1.6** All new piping, fitting and penetration must be supplied by The Contractor and all sizes to be as per original systems. Piping must be Sch 40 seamless steel. The length of new piping to be taken as **total** 700 feet for bidding purpose and the contractor must bid a unit cost per linear ft. **Pipe sizes and lengths: ½" -50 ft; ¾" -100 ft; 1"-200 ft; 1½"-100 ft; 2"-250 ft.** Any necessary adjustments will be through PSPC 1379 action.

EE) At H-56 Fire Main Piping Replacement

H-56 Fire Main Piping Replacement

**3.1.6** The Contractor must replace all fire main piping from fire pumps located in Engine Room to all spaces with fire main supply as per attached drawings. The length of new piping to be taken as **total** 750 feet for bidding purpose and the contractor must bid a unit cost per linear ft. Fire Main Material: 2" and larger is Schedule 40 Seamed galvanized pipe and 1-1/2" and smaller is Schedule 80 Seamed galvanized pipe. **Pipe sizes and lengths: 1½" –200 ft; 2"-150 ft; 2½"-200 ft; 3"-200 ft.** Any necessary adjustments will be through PSPC 1379 action.
