2. Questions and Answers

Question 1: To keep the sample costs low, would you accept the written mark on the closure tape to be in English only? The current version of the tape marking says "VOID" when the bag is reopened.

Answer 1: Annex C – Mandatory Criteria M7 will be amended to remove the language requirement.

Question 2: To keep the sample costs low, would you accept markings to be printed on one (1) size, rather than on all sizes? Marking requires customized printing plates to be made individually for each size of the bag.

Answer 2: As per Annex C – Mandatory Criteria M14 and M15, the wording on the marking label will not be evaluated at pre-award.

Question 3: Please see attached the wording on the marking label. Would this format be acceptable for sampling?

Answer 3: As per Annex C – Mandatory Criteria M14 and M15, the printing on the marking label will not be evaluated at pre-award.

Questions 4: Would you be able to provide a technical drawing for any one of the sizes and/or actual images of the bags currently being used?

Answer 4: Refer to attachment for technical drawing of Size A evidence bag. Pictures are also attached.

Question 5: Could you please provide us some photos of the front and back of evidence bag for my reference?

Answer 5: Refer to Question and Answer 4.

Question 6: Could you please provide the total number of printed colors (and ink coverage) per bag?

Answer 6: Printing colour is not being evaluated at pre-award. For post-contract award, the RCMP's specific colour requirements are identified in 4.3 and 4.4 of the Purchase Description. If a colour is not specified, it is at the discretion of the supplier.

Question 7: Could you please provide us drawing and labels of evidence bags for making samples?

Answer 7: Refer to Question and Answer 4.

Question 8: Is there an allowable variance from uniformity of the bags?

Answer 8: As per Annex C – Mandatory Requirements, M19 the size tolerance is ± 5 mm.

3. Annex C – Mandatory requirements

M7	Any attempt to open the tamperproof evidence bags must result in visual damage to the bag or tamper evident seal. Re-sealable bags do not meet this requirement. Paper seals or seals which reveal a pattern or other marking to denote evidence of tampering are acceptable. If a tamper evident seal that reveals wording is used, the words must be in English and French. Refer to paragraph 4.1.2 (Tamper Evident Seal) of the Purchase Description.
