Questions and Answers

Q1. On the site visit phone call it was stated that working hours are 8:30 am to 5:30 pm. In the documents it is stated as 7 am to 5 pm, can you clarify the working hours and does this include the ability to work Saturday?

A1. Addressed in Amendment 002. The posted tender documents, Specifications, and Drawings take precedence over any information provided during the Bidder's Meeting. The hours of work remain as per Specification Section 01 11 00, 1.13, which state that the working hours are 07:00 to 19:00 Monday to Saturday, **inclusive**.

Q2. The RFP docs state that the project is to start 20 days after the contract has been finalized. On the site visit call it was stated that this was intended to be a summer project. Can you verify the expected onsite start date for the project?

A2. The intent is to complete the project during the dry season, especially the excavation portions of the work. The Specifications (01 11 00 1.12) text is as follows: "Work to be initiated: as soon as practical, and no later than 20 days, after Contract notice."

The Proponent must supply a schedule for the work. See 01 11 00 Sections 1.12.3 and 1.12.4 for Substantial Performance and Final Completion deadlines. The Substantial Completion deadline and Certificates of Destruction (supporting the Certificate of Completion) are considered most likely to drive the schedule and require the earliest possible start date.

Examples of Work that are required prior to mobilization or other site Work components includes but are not limited to

- pre-Work submissions (01 33 00),
- preconstruction (Kickoff) meeting (01 31 19 Section 1.6) and
- project design components (01 11 00 and 01 25 20).

Q3. Is the contractor responsible for any post stabilization analytical verification that the stabilized material has met a leachate threshold?

A3. No

Q4. Will any post stabilization analytical verification be completed for the project?

A4. Canada may sample the stabilized material for the record only, post stabilization analytical verification is not a requirement for this contract.

Q5. Is it acceptable that the QP PFAS individual that is chosen by the contractor be from outside of Canada, even if they cannot meet the security clearance requirements for CFB Comox? Further to this, is it required that the QP PFAS visit the project site?

A5. The Specifications do not stipulate citizenship or residency of the QP-PFAS, nor do they stipulate mandatory site visits by the QP-PFAS. The QP-PFAS must determine, within their professional college/associations code of ethics, the necessary information required to provide technically sound evaluations of the work, as required. See 01 11 55 Section 1.2.58.2 for requirements related to QP-PFAS familiarity with applicable regulations. There is a security requirement for this project as per Special Instruction SI21 in the RFP document.

Q6. Is it the responsibility of the Contractor to provide a project Environmental Monitor or will the Owner's onsite Rep be completing that role?

A6. Monitoring is a necessary component of the Contractor's Work as detailed in many parts of the Specifications. For more details, Proponents are directed to 01 32 43 (Environmental Protection) and to the EMP in Annex C. The EMP Section 4 specifically covers environmental responsibilities and stipulates that the Contractor retain an Environmental Monitor.

Q7. Is there a water source available onsite for project use?

A7. The only nearby water source available during the work is the fire hydrant to be removed/replaced during the work. Alternate water sources may be arranged by request and coordination via the Departmental Representative, but have not been identified at this time.

Q8. At what volume and rate can the “owner supplied” water treatment contractor accept contaminated water from the FFTA Source Control Project?

A8. In addition to the requirements in 02 61 00.01, see 01 35 13.43 Section 1.13 for details regarding maximum daily volumes and maximum turbidity for provision to the DND WTU.

Q9. Will waste water from the specified wheel wash systems be considered “PFAS contaminated”, and require transport to, and treatment at, the water treatment facility?

A9. Yes

Q10. Can you confirm what type of waste water is generated from fire fighting training? This information is necessary to design the holding tanks.

A10. Only potable water is intended for fire fighting training at CFB Comox. However, an accidental release of AFFF during training exercise cannot be ruled out, so it is possible that the training water could potentially contain PFAS. No data is available regarding post-training water quality.

All other terms and conditions remain unchanged.
