



Product Category(ies): 1,2 & 5 + 3, & 6B



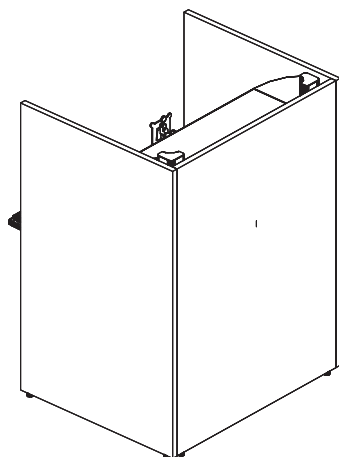
