DELETE in its entirety and REPLACE with "2BH073001B – Attachment C – Substantiation of Technical Compliance –v2"

Modification 4

On page 38 of the Solicitation, at 1. L),

DELETE: "Proof of Cisco compliance be provided in the bid."

REPLACE: "Proof of Cisco compliance must be provided in the bid."

Modification 5

On page 39 of the Solicitation, at Item 2,

DELETE the following in its ENTIRETY:

Item	2. Supply Chain Integrity Requirement
2. a)	Webcam OEMs must have a mature and comprehensive Supply Chain Integrity (SCI) process in place. This process must involve the mitigation of the infiltration of fraudulent or counterfeit components, as well as the mitigation of the introduction of hardware-based threat vectors during the manufacturing process, and throughout the subsequent supply chain and delivery channel up to final delivery. The webcam OEM must be involved in at least one of the following: 1. ISO/IEC 20243:2015 - Open Trusted Technology Provider Standard (O-TTPS) – OEM Accreditation 2. ISO 28000 – Supply Chain Resiliency – OEM certification 3. ISO – 15408 – Common Criteria – product certification

On page 39 of the Solicitation, in Item 3. A),

DELETE in its ENTIRETY and REPLACE WITH:

Webcam OEM must have the following certifications:

- i) ISO 14001

Bidders must submit proof in their bid submission. If necessary, a correlation between the names appearing on the mandatory ISO certifications and the product manufacturer's name must be provided in the bid. That correlation must also be apparent through standard web searches.
