### **QUESTIONS AND ANSWERS**

#### **Question 1:**

Just reviewing this request for proposal and need confirmation that the dates indicated are correct. It's noted that pricing is in effect until March 2022 and that option periods, (ie; pages 12-13) are into fiscal year of March 2023.

Are those dates accurate? When do you plan to purchase Table 1: Initial Contract Period?

#### **Answer 1:**

The dates are accurate, we plan to purchase the initial Contract Period goods in April 2021 for delivery as soon as possible. The first option period will be exercised at the end of the Fiscal Year around March 2022 if it is determined that we require the remaining goods for FY 22/23.

#### **Question 2:**

Can we submit an alternative solution for the matrix?

#### **Answer 2:**

No, unfortunately an alternative solution is not possible due to the following reasons:

- this item was selected to meet the current configuration of equipment specifications in operation among allied nations;
- to maintain commonality for sparing purposes;
- this specific model is interchangeable with the switches currently in use within the classified system; and
- exchanging this switch for one from another manufacturer could change the system configuration.
