Q12.) The required services have been described in the RS section of the RFP.

We would like you to clarify the definition of “marine”. Marine can be defined as either “Marine Engineering” or as “Marine Coastal, Environmental and Permitting aspects”

In the Required Services 1.0 through 11, we only find reference to “infrastructure” , “equipment” and “ecological and environmental”. The hypothetical project does not make reference to any marine scope either.

Therefore can you please clarify whether you are looking for marine expertise as in :

- a) Marine Structural Engineering: Quaywalls, Piled Foundations, Fendering Systems, Graving Dock Foundation, Graving Dock sill and door systems, bollards, mooring systems, navigation, ship lift systems, shipyard masterplan layout, ship movement rail systems and the like OR
- b) Marine Sciences and Coastal Engineering : Sediment transport, contaminated sediments, aquatic environmental impact, wave and current modelling, dispersion modelling, mammal disturbance and the like.

A12.) We are looking for Marine Structural Engineering.

Q13.) The RFSO asks for us to include 15 resumes – this number is comprised of one (1) c.v. for each of the seven (7) major disciplines and eight (8) c.v.'s of project personnel which will perform the majority of the work. The RFSO asks for each of these resumes to be two pages, which works out to 30 pages of resumes within the submission. This leaves 5 pages remaining for the rest of the submission.

In the interest of a fair evaluation (i.e. each consultant providing the same volume of resumes), we are requesting that either the resumes be removed from the page count or the page count be extended to 50 pages (including resumes).

A13.) The page limit is increased to fifty (50) pages.

Q14.) Regarding 3.2.5, Amendment 001 states:

“The bidder must provide eight (8) resumes for project personnel with no more than 2 resumes per discipline (for example, resumes for: 2 civil, 2 structural, 2 electrical, 2 environmental = 8 resumes; OR, 1 civil, 2 structural, 2 mechanical, 1 electrical, 2 environmental = 8 resumes).”

As the discretion is left up to the consultants on which resumes to include (i.e. there a variety of arrangements that the 8 resumes can be made up of), can PSPC confirm that each arrangement of resumes will be eligible for receiving full marks (i.e. our score won't be docked if we choose to not include a discipline)?

A14.) Yes, bidders are eligible for full marks if eight (8) resumes are provide as per the requirements within this section, regardless of which disciplines are omitted.
