The following tender addendum is issued to advise bidders of the following:

1. Work is to take place during regular core hours of Monday to Friday 8am to 4pm. Submit your bids accordingly. If CSC wishes to undertake night and weekend work, that will be negotiated after contract award through a Change Order.
2. The overall project schedule is indicated as 16 weeks which is the overall schedule for the project including the interior renovation as well as exterior yard work. Due to the urgency of the need for putting the interior space to its intended use, CSC would like the interior work to be completed in 12 weeks +/- 2 weeks, while the exterior yard work could be completed in 16 weeks +/- 2 weeks.
3. The winning bidder's Site Safety Plan is to include specific sections on the contractor's Covid-19 safety plan which will be reviewed by PSPC and CSC site and may need to be modified if required.
4. The CSC institution where the project takes place (Edmonton Institution for Women, EIFW) may on short notice modify access to the institution and to the work site due to any Covid-19 outbreaks either among inmates, employees, contractors or the Edmonton community in general.
