### **REQUEST FOR PROPOSAL AMENDMENT NO. 004**

Request for Proposal Amendment no. 004 is raised for the following reasons:

- 1. To provide questions and answers; and
- 2. To make modifications to the RFP.

Question 13: Is Statistics Canada needing the scanning feature to be in colour or just B&W, scan is needed?

**Answer 13:** B&W scanning is the minimum requirement. Scanning in colour is optional and not a mandatory requirement but will be accepted.

**Question 14:** Regarding Answer # 4 from the latest amendment, if we are proposing a device that already comes with 1500 or higher page yield cartridge in the MFP, do we still need to bid any extra cartridges in our response?

**Answer 14:** Yes, in addition to the cartridge included with the device, Statistics Canada requires spare cartridges as specified in Annex B, Basis of Payment, Line Item 2a. or 2b. See Modification 014 and Modification 015.

**Question 15:** Can you please elaborate on the requirement for additional toners, some machines come with a "full toner" included in the box price versus a "start toner". The price of a machine is affected by the amount of toner included with the box as a standard. If a machine already has a 1,000 included with the box, is a spare toner even required? It would be a good idea to specify exactly the total amount of printing a machine should do with "starter toner" plus the spare toners.

Answer 15: Spare toner is required. See Answer 14.

**Question 16:** Our smallest device is 15.8 x 14.3 x 14.4 in because it also includes a 250 sheet tray versus 100 sheets, will this be accepted?

**Answer 16:** This will not be accepted as it exceeds the maximum dimensions listed in Annex A – Statement of Work.

On page 19 of the RFP, Part 7 Resulting Contract Clauses, section 3 Optional Goods:

## Delete in its entirety and replace with:

The Contractor grants to Canada the irrevocable option to acquire an additional 250 devices including toner and cables described at Annex A of the Contract under the same terms and conditions and at the prices stated in the Contract. The option may only be exercised by the Contracting Authority by notice in writing and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the option at any time before the expiry of the Contract by sending a written notice to the Contractor.
