PART 1 - GENERAL INFORMATION

1.1 Requirement

The requirement is detailed under Article 6.2 of the resulting contract clauses.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2020-05-28) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.2 Submission of Bids

Bids must be submitted only to the Public Works and Government Services Canada (PWGSC) Bid Receiving Unit specified below by the date and time indicated on page 1 of the bid solicitation:

Suppliers are strongly encouraged to submit bids electronically using the Canada Post epost Connect application for the subject bid solicitation. The Bidder must send an email requesting to open an epost Connect conversation to the following address:

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

It is the Bidder's responsibility to ensure the request for opening an epost Connect conversation is sent to the email address above at least six days before the solicitation closing date.

Faxed bids will be accepted at 1-418-566-6167.

Hard copy (submitted in person or via mail/courier) bids will not be accepted for the subject bid solicitation.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 7 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Manitoba.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.2 Basis of Selection

4.2.1 Basis of Selection – Mandatory Technical Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

REQUIREMENT

LASER ENGRAVER

1.0 BACKGROUND

The Department of National Defence requires the supply, delivery, and set-up of one (1) Laser Engraver to 3 CDSB Wainwright Maintenance Section located at Denwood, Alberta in order to facilitate the engraving of curved and flat surfaces of equipment in support of any brigade or unit that is in the training area. The laser engraver will be used for personalization or customization to products made of wood, plastic, or even glass. A thorough user specific on-site demonstration on the proper use of the requirement is preferred. If this is not feasible, then virtual tutorials would be acceptable if technical support is available for troubleshooting or clarification on processes. All deliverables must be received on or prior to March 26, 2021.

2.0 CONTRACTOR RESPONSIBILITIES

- 2.1 The Contractor is responsible for the delivery of all components to the following location:

- 2.2 The Contractor will be responsible for removing and disposing of all packing materials
- 2.3 Set-up and demonstration or virtual tutorials for a group of up to 4 people must be provided.
- 2.4 Any warning and instruction plates/decals, handles, non-slip surfaces, heat shields and/or guards shall be in place at time of delivery.
- 2.5 Delivery arrangements shall be coordinated with the technical authority no later than 1 week prior to the mandatory delivery date.

3.0 DND RESPONSIBILITIES

- 3.1 DND will be responsible for ensuring that all required electrical outlets or connections are visible and working prior to the scheduled delivery date.

4.0 TECHNICAL SUPPORT

- 4.1 Supplier must be able to provide service and repair support (during the Warranty period) to the hardware and software components within 5 business days from receipt of request

5.0 MINIMUM MANDATORY PERFORMANCE SPECIFICATIONS

- 5.1 Engraver must be designed to be used in an industrial setting.
- 5.2 Have the ability to engrave acrylic, glass, laminates, leather, paper, plastic, stone, textiles, wood, and metal up to 0.5mm in thickness.
- 5.3 Have the ability to engrave on curved surfaces (Rotary capability) up to and including 24 inches (609.6mm) long.
- 5.4 Must have an Interlock Safety System.
- 5.5 Must have a dust reduction or mitigation system.
- 5.6 Include a CO2 laser Dynamic output.
- 5.7 Include a Fiber laser Dynamic output.
- 5.8 Indicate the name of the Standards Council of Canada (SCC) accredited organization that has approved the electrical equipment being offered
- 5.9 Equipment must operate on 120V or 220/240V AC outlets
- 5.10 Equipment dimensions – no larger than 125 cm (long) x 125 cm (wide) x 200 cm (height)
- 5.11 Working platform – equipment must be able to engrave objects within the following surface area – minimum of 81 cm x 50 cm to a maximum of 100 cm x 100 cm
- 5.12 Vertical working platform – equipment must be able to engrave objects with a minimum height of 20 cm to a maximum of 31.5 cm
