This is amendment 005 to our solicitation, in order to answer questions from the industry.

Enquiries – Bid solicitation – Clause #2.3

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of enquiries.

Here are the questions we have received:

Question 9: We are concerned with some of the measurement numbers that were sent back. Our quick links are 83mm ID long and 105 mm OD long. When added to the original dimension of the nets it would exceed their measurements with the quick links. They allow 95 mm to the width of the net. We plan on making the nets under tension with the quick links installed so the important measurement to us is the end of quick links (which get attached to the frame eyes) Please confirm that the net sizes from quick link to quick link ends are 3525 mm x 1855 mm and 3595 mm x 1855 mm . The photo you sent was helpful and as you can see the quick link extends quite a bit past the net ends.

Answer 9: The measurements of 3525mm x 1855mm and 3595mm x 1855mm were taken at the end of the quick links (See black line on the picture). With quick links of 83mm inside (blue dots on the picture) and 105mm outside (red dots on the picture).

Question 10: Since hardware sizes can vary, are we to assume that the measurement most important is the quick link to quick link dimension?

Answer 10: The measurements of 3525mm x 1855mm and 3595mm x 1855mm were taken at the end of the quick links (See black line on the picture). With quick links of 83mm inside (blue dots on the picture) and 105mm outside (red dots on the picture on next page).
