AMENDMENT 001

This amendment aims to publish questions and answers.

Q1 : Regarding section 3.3 *Communications* : Our system is passive and uses fibre as the medium of communication between the pole-mounted device & logging equipment. Is fibre available within your network and an option for communication in this project?

A1 : No, fibre is not available as a means of communication for this project.

Q2 : Annex B, Article #2 indicates that there will be individual sensors deployed at different 3-phase transformers secondaries. Usually this means 3 sensors (one for each phase). Can you verify if you need a total of 4 3-phase sensors (12 sensors) or simply 4?

A2 : We need a total of 6 individual sensors for single-phase transformer secondaries and 4 individual sensors for three-phase transformer secondaries. These last 4 sensors need to be 3-phase. Consequently, if your sensors require one device per phase, that would mean 12 devices.

Q3 : I believe each sensor location will need a power meter + cellular router to collect, record and transmit the information. Is this correct? I ask because no direct mention of the meter is made.

A3 : Yes, it is correct. Every sensor needs to be able to collect, record and transmit the information.

Q4 : When accessed remotely, does the end user want to visualize the data on an HTML web page, or do they want the meter to communicate via a certain protocol, e.g. Modbus, BACnet, etc.?

A4 : The data visualization on an HTML web page is optional as long as the data can be retrieved remotely and that cellular data communication is available.

All other terms and conditions remain unchanged.
