Amendment 002

This amendment is raised to answer bidder questions and distribute information from the site visit.

A. Question and Answers

- Q1. There are no requirements or specifications for certain parts of this project? Can this be provided?
- A1. There are no specifications included with this solicitation as PCA is looking for a contractor to design and build under the guidelines outlined in the RFP and project brief. If there are any specific areas in the project brief that bidders require further clarification, information or detail, please submit these questions in writing.
- Q2. Please clarify the discrepancy within plans for renovations required in rooms 112 and 115.
- A2. For the purposes of tendering, assume these two spaces are to remain as existing.
- Q3. Please confirm the age of the existing main municipal sewer line related to new sanitary sewer required for room 105, details for required sanitary tie-in, as well as any other utility conflicts.

 A3. Existing sewer line was replaced in 1999 and is 8" PVC pipe. Required tie-in service connection will be made by either: Installed in-line tee, or by use of a saddle to a machine tapped (cored) hole between the spring line and the top of the main pipe. Considerations for all aspects of work including proper backfill and embedment material shall be made and included with all other requirements submitted within shop drawings upon contract award. See utilities overhead snip below.



- Q4. Please clarify ducting requirements for renovated spaces.
- A4. Refer to Project Brief Section 2.2.7. Supply and return air ducting is required for all renovated spaces. Where ducting is ran along building perimeter, it shall be assumed that ducting terminations and diffusers/grilles will be either finished flush to floor/wall or encased in a small wooden bulkhead finished to match respective wall surfaces.
- Q5. How will the upcoming highway construction closures between Golden and Field affect this project? A5. Parks Canada will include contractors (including sub-trades/sub-contractors) on a manifest of local traffic permitted to be escorted between the Field to Golden closure at designated times of the day as regulated by the Kicking Horse Canyon upgrade project. Timelines are subject to change and are not guaranteed.
- Q6. Please clarify heat requirements in washroom spaces being renovated.
- A6. Each washroom space will require: A unit temperature controlled baseboard space heater rated for the area, as well as a typical washroom exhaust fan properly terminated to the exterior of the building and controlled by a wall mounted switch.
