**Question 1:**

In regards to Lines 009 & 010, what application are these valves being used for?

**Answer 1:**

This is a pneumatically operated valve fitted with remote open/close indication in CBRN HQ1 (When a ship closes down for a CBRN attack).

**Question 2:**

In regards to Lines 013 & 014, what shock testing specification do the parts have to meet?

**Answer 2:**

All units should comply with specification D-03-003-007-SG-000 for design and test criteria for shock resistant equipment. Clause 5.2.4 of the RFP will now apply to Lines 13 & 14 of the solicitation.

**Extension:**

The closing date of the solicitation will be extended to February 25<sup>th</sup>, 2021.
