Amendment 002 is raised to publish questions and answers:

Q1. In workstation typical A, can you advise if 2x duplexes are required for panel type P3, or could only 1 be supplied? If two are required, can the second one be moved into panel type P5?

A1. Yes, one duplex outlet from P3 panel can be moved to P5 panel will be accepted as an option.

Q2. In workstation typical B, can you advise if 2x duplexes are required for panel type P7, or could only 1 be supplied? If two are required, can the second one be moved into panel type P10?

A2. No this is not an acceptable option.

Q3. Category 6A, item #2, Tag A2, would the customer accept a back height of 15.5" above the seat which would concord with a mid-back? By providing little to no tolerances, this favors specific manufacturers and doesn't allow for a fair bidding process.

A3. Mid height back range is from 15" – 18".

Q4. Category 6B, item #1, Tag B1 , can customer confirm if this pedestal base on this table can be available in paint, polished aluminum OR wood, and not all three?

A4. Must be available in either painted metal, and polished aluminum.

Q5. Category 6B, item #2, Tag B3 , can customer confirm if the post legs (support) can be available in paint, polished aluminum OR wood, and not all three?

A5. Must be available in either painted metal, and polished aluminum.

Q6. Category 6B, item #4, Tag B5 , can customer confirm if this pedestal base on this table can be available in paint, polished aluminum OR wood, and not all three?

A6. Must be available in either painted metal, and polished aluminum.

Q7. Category 6B, item #7, Tag B8 , can customer confirm if the post legs (support) can be available in paint, polished aluminum OR wood, and not all three?

A7. Must be available in either painted metal, and polished aluminum.

Q8. Category 6B, item 8, Tag B9, would the customer also accept laminate?

A8. We will also accept a high pressure laminate in a wood finish as an option.

Q9. Category 6D, item #1, Tag D1, would the customer accept a width range of 67-69" also be accepted?

A9. No, this is a three seater sofa.

Q10. Category 6E, item #1, Tag E1, would the customer accept a height of 39"H, 53" or 54"H?

A10. No, preferred range of 42" – 45"

Q11. Category 6E, item #2, Tag E2, would the customer accept a seat width of 63"?

A11. No, will not be accepted.

Q12. Category 6E, item #2, Tag E2, would the customer accept a seat depth of 22" with the back?

A12. No, will not be accepted.

Q13. Category 6E, item #3, Tag E3, would the customer accept a seat width of 36"?

A13. No, will not be accepted.

Q14. Category 6E, item #3, Tag E3, would the customer accept a seat depth of 30"?

A14. No, will not be accepted.

Q15. CAT3 item 1 - confirming that an electronic lock is what is required?

A15. No, CST states filing cabinet is keyless.

Q16. CAT6 item 2 A2 - per the plans, there are three installations, i) 3 units with boardroom table B9 for a total length of 180", will the Client also accept 3 units for a total length of 182" (52" + 78" + 52")? ii) 4 units in two-ganged sections with tables B3 at 120"W ea., will the Client also accept 2 units ganged together with a total length of 130" (78" + 52") iii) 1 unit in a private spaces with a B10 table, would the Client also accept a unit that is 52"W or two ganged units that add up to 63.5"W?

i.) No, will not accept the alternate as an option. Banquettes need to be equal in width.

iii.) Yes, will be accepted as an option if banquets are equal in width ONLY.

Q17. CAT6 item 3 A3 - will the Client also respectively accept three units of 72"W each instead of 6 units at approx 36"W ea?

A17. Yes, we will accept the 72" W banquette where table 'B9' is to be installed.

No, we will not accept unless can provide a banquette that will fit in the clearance of 88" where 'B4' table to be installed.

Q18. CAT6A item 6 A6 - will the Client respectively also accept i) sled base option or ii) laminated bent plywood option.

A18. Both sled base and laminated bend plywood with a seat with seat pad will also be accepted as an option.

Q19. CAT6B items 11 & 12 - due to Covid-19 supply chain issues, will the Client also accept laminate or wood veneer option?

A19. No not acceptable as an option.

Q20. CAT6B item 10, NSA table - typically table supports are not in high pressure laminate, this raises the overall cost for a non-worksurface component. Will the Client accept LPL for the panel base?

A20. Panel base acceptable with low pressure laminate.

Q21. CAT6C item 1 - will the Client also accept a sled base, given the height of the chair a sled base addresses stability issues when used by persons averaging 275-300 lbs at this height.

Q23. CAT6C item 6 - Will the Client also respectively accept an end gable table option?

A23. Yes, end gable is acceptable as an option.

Q24. CAT6C item 11 - will the Client accept a sled base (see Q21) to align with the same series requirements?

A24. There is no item 11.

Q25. CAT6D item 8 - will the Client also respectively accept an end gable table option?

A25. Yes, end gable is acceptable.

Q26. CAT6D item 10 - will the Client also accept a sled base, given the height of the chair a sled base addresses stability issues when used by persons averaging 275-300 lbs at this height.

A26. Sled base will also be accepted as an option ONLY if the base does not impede on the size requirements of the chair.

Q27. Will the shipping location be able to accommodate a 53 foot trailer for the delivery of the goods? If not, what is the maximum truck length the location is able to accommodate?

A27. No. A moving truck 22-26ft with a lift gate must be used.

Q28. Category 1A, customer is asking for a frosted glass stack (framed in glass panel), therefore I am asking if we could do frameless, which would now be part of category 1B as an add-on if accepted?

A28. Yes, this would be accepted as an option.

Q29. In Table 1 –Product Table – CATEGORY 6C, for 6CKIVAREWL48L72TNXX which requires a waterfall edge support, would 6CKIVAREGL48L72PNXX which is end gable support, be acceptable?

A29. Yes, this will be accepted as an option.
