A. Questions & Answers

Q1. In the RFP #1000350043 FOOD/WATER/SURVIVAL/FIRST AID REPLACEMENT PRODUCTS FOR VANCOUVER TAX SERVICES OFFICE, would you please clarify item M3 on page 18 under column B mandatory Requirements.

This criteria stated:

“The Bidder must have received a certification from a government entity, authorizing the Bidder to supply consumable products in Canada. This authorization can be from any level of government. To demonstrate compliance with this mandatory requirement, a copy of this certification must be provided.”

Are you able to outline which certifications the CRA will accept? In the past, our firm's emergency food and water rations were certified by Transport Canada, based on SOLAS (Survival of Life at Sea) international standard, for 25 years, up until 2018, when Transport Canada advised that they were no longer providing the certification.

A1. Given the increased difficulty in providing the above certification, Mandatory Criteria M3 will be deleted from the RFP. Please refer to Amend #2 to the RFP, listed below.
