Solicitation Amendment #02

I. This amendment is raised to respond to the following Industry questions:

Q1: Is it a mandatory requirement that the Interior Design professional is a licensed/accredited Interior Designer (in an Atlantic province) or alternatively, can an Architect provide and stamp these services?

R1: As per M4 of the Mandatory Requirements, the supplier must be a member of the registered class or equal class of membership of the regulating provincial Interior Design Association in the province of Nova Scotia and/or New Brunswick.

Q2: Do accredited professionals need to be licensed in the Atlantic region at the time of submission, or can such designation be applied upon award?

R2: As per M3 of the Mandatory Requirements, firm must be a licensed architect in at least one Atlantic province with plans to become registered in any other province that they submit for consideration.

Q3: We would like to query whether engineering firms would be considered for this standing agreement?

R3: No, please refer to M3 and M4 of the Mandatory Requirements in the Request for Proposals.

All other terms and conditions remain unchanged.
