Questions and Answers

Q1. Can the CFB Comox FFTA Source Control Project PFAS Destruction and Disposal Facility Forms be signed and stamped by a QP PFAS that is on the bidders team (and meets the owner specs for a QP PFAS) but is not the primary QP PFAS named in the Key Personnel list to be evaluated in the Technical Evaluation Component of the RFP?

A1. Yes. The contract does not prohibit multiple QP-PFAS. As per previous Q &A, tender evaluation will be as stated in Appendix 4 SUBMISSION REQUIREMENTS AND EVALUATION including but not limited to Section 2.2b

(1). Notwithstanding the submission documents, it is the Contractor's sole responsibility to provide the Work in accordance with the Contract requirements.

Q2. Who is the appropriate QP to sign off on the Mandatory Disposal Facility Forms if the facilities are not located in B.C.? The Mandatory Disposal Facility Forms require a Qualified Professional Sign and stamp the form. Per the specification 01 11 55 general Instructions section 1.2.57 a QP is:

"a person who is registered in relevant jurisdiction with his or her appropriate professional college/association, acts under that professional college/association's code of ethics, and is subject to disciplinary action by that professional college/association, and through suitable education, experience, accreditation and knowledge can be reasonably relied on to provide advice within his or her area of expertise. Only full membership will be considered to be a QP (i.e. no "in training" designations). Includes:

1.2.57.1. Association of the Chemical Profession of British Columbia.

1.2.57.2. British Columbia College of Applied Biology.

1.2.57.3. British Columbia Institute of Agrologists.

1.2.57.4. Engineers and Geoscientists British Columbia."

Does this mean that the QP MUST be registered in BC? We are proposing multiple facilities which are not in the BC province. Could our Facility Engineer's sign off on these forms (not registered in B.C.)?

A2. The examples provided in Section 01 11 55, 1.2.57 are not intended to be an exhaustive list. The Qualified Professional (QP) definition provided includes, but is not limited to the following relevant items for this question:

- "relevant jurisdiction"

- "appropriate professional college/association"

- "provide advice within his or her area of expertise"

For facilities located outside of BC, a QP registered in the appropriate jurisdiction will be required.

Q3. Could our Qualified PFAS Professional sign off on these disposal forms as the QP (he is registered in B.C.)?

A3. For this project, Qualified Professionals (including QP PFAS) may serve multiple roles, providing that they meet the definition for any specified role(s).

Q4. Would it be possible to book a site visit for sometime next week?

A4. No site visits are allowed for this solicitation.
