REQUEST FOR PROPOSAL AMENDMENT NO. 005

Request for Proposal Amendment no. 005 is raised for the following reasons:

- 1. To provide questions and answers; and
- 2. To make modifications to the RFP.

Question 17: Would the Government of Canada consider removing the size limitation of the device and replacing it with a max of 10KG MFP weight limit instead? Given the explanation as to why such a small device dimension is listed, a device weight is more of a universal and fair measure. Currently a bid response is disqualified because 1 of the 3 measurements is over the max listed size though overall, it could be the smallest sized MFP proposed. The weight is the most important factor when you are considering shipping, moving, handling and installation of a device by end users.

Answer 17: Statistics Canada will not remove the size limitations.

Question 18: Annex B 2.a does the ink yield must meet 500 pages per cartridges or can offer ink cartridges that yield 250-300 pages and include 3 or 4 cartridges to meet the 1,000 page require? With the demand on printers and inks the large capacity inks are in high demand.

Answer 18: Statistics Canada will accept multiple sets of ink/toner, as long as the combined total estimated yield for each set is 1000 pages or more. This would be over and above the cartridges per-installed in the device. See Modification 016 and Modification 017.

On page 27 of the RFP, Annex A – Statement of Work: Delete in its entirety and replace with:

1. Requirement

Statistics Canada has a requirement for 250 multifunction devices with the option to purchase an additional 250 units over the following year. This Contract is for the supply and delivery of the equipment.

Each device must include toner and a 6 foot cable. Statistics Canada also requires spare toner in addition to the toner that comes with the device.

2. Mandatory technical requirement

The devices must meet the following mandatory requirements:
