**Q-1. What is the anticipated yearly volume?**

A-1. Due to the unforeseen measures applied to the Department as a result of COVID-19, the projected annual volume is approximately 400,000 images. As this is strictly an estimate and requirements can rapidly change, bidders must demonstrate the ability through M.1.1.2 to provide copying / short run printing of a minimum of 500,000.00 images from hard copy documents over the period of one (1) year to ensure future demand can be met (if needed).

**Q-2. Is it fair to assume a similar volume of a quarter-million (250,000) impressions per year as per our experience as the current supplier?**

A-2. This has been answered in the above response under A-1.

**Q-3. Why is there a difference between tendering criteria for the same security reproduction services between regional offices?**

A-3. Please note that all individual solicitation have their own tendering criteria for security pending on the needs of the specific requirement. Please refer to section 7.3 Security Requirements for this solicitation.

**Q-4. How many binders will be required for this bid?**

A-4. Due to the unforeseen measures applied to the Department as a result of COVID-19, the projected annual volume of binders is approximately 300. As this is strictly an estimate and requirements can rapidly change, bidders must demonstrate the ability to provide a minimum of 400 binders during the period of one (1) year to ensure future demand can be met (if needed).

**Q-5. Will you accept the use of 80lb cover instead of 65lb cover?**

A-5. 65lbs is the standard weight of cover stock paper provided to the courts.
