To address questions pertaining to the Solicitation.

#### Question 1

Would you be able to remove the March 31 delivery deadline, as there is a global constraint on Intel chips and very few providers are able to deliver that quantity for March 31. Please let me know so we understand if we want to move forward with this opportunity?

#### Answer 1

No, the March 31st delivery deadline can't be removed for this requirement.

#### **Question 2**

Can you please clarify a few questions regarding 2BH080357/A:

- 1) In order to provide the crown with the best possible value, would it consider changing the screen size to a range from 14-15.6? This would allow more options to be presented to the crown.
- 2) Would the crown accept RAM speed of 2133MHz?
- 3) Would the crown accept two different keyboards (English and French) vs. a bilingual keyboard
- 4) Would the crown accept a weight of 4.9lbs?
- Would the crown accept the use of Numlok function to fulfill the requirement of an integrated numeric keypad?

### **Answer 2**
