Question 01	<ul style="list-style-type: none">• Item 3.9 (i-l) P8-9/18is a requirement that pertains to trailer body connections - (i) The brake system must be provided with a trailer brake control mounted on or near (ii) Two (2) air-lines must be provided for connection to the trailer air system; (iii) The service air-line must be blue and the emergency air-line red; and (iv) Trailer brake hoses must be coiled behind the cab or cab/sleeper. <p>Question :This indicates that requirement is a Tractor . Could this be an error ? Aluminum Body requested is a chassis mounted .</p>
Answer 01	Subparagraphs 3.9 i to l will be removed from the Purchase Description
Question 01	<ul style="list-style-type: none">• Item 3.2 under Equipment P 11/18 e. Aluminum Compartment Requirement : The vehicle must be provided with an aluminum compartment in a Technical Authority approved location; <p>Question: Can this location be determined (RH or LH of the Frame side)?</p>
Answer 01	The aluminum compartment must be installed on the frame rail of the vehicle.
