QUESTIONS AND ANSWERS

NOTE: These are the last questions that will be responded to. Any further questions submitted to the contracting authority will not be addressed.

Question 15: Given the terms of the solicitation, the security requirement do not make any sense. You require Facility Access II (which access is not defined anywhere), yet you do not know to which facility we may be delivering and installing. Further, bids must identify the names of the individuals that will access the facilities for the delivery and installation. That is impossible to determine so far into the future given you do not want the chairs installed prior to October 2021. We would be happy to provide the names of the specific individuals that would effect the delivery and installation at least 4 weeks in advance of delivery. Please provide feedback on this requirement.

Answer 15: Security requirement is only required for delivery and installation at 73 Leikin in October 2021. Note that wording has been changed to: Security requirement must be met before the work is to be performed. Please see revision 1 below.

Question 16: You want all chairs to be delivered to an undisclosed location in Ottawa prior to March 31 and that location can only accommodate a 5-ton truck at maximum and would not have a loading dock.

Answer 16: Correct. The storage location has yet to be determined.

Question 17: The chairs need to be delivered to the above location fully assembled and boxed so that they may be safely stacked and stored until approximately October 2021.

Answer 17: Chairs are to be delivered to the above location, fully assembled and wrapped (either in plastic or shrink-wrapped) so that they may be safely stored.

Question 18: In approximately October 2021, you will require the bidder to return to site, to unbox the chairs, remove the packaging from site and place the chairs in their final use location in the same building.

Answer 18: No. No installation will be required of chairs in storage. Bidder will only be required to install, at site, any chairs delivered in October 2021.

Question 19: To clarify, the chairs will NOT require to be transferred by truck to a separate location from the initial delivery location for purpose of installation, correct?

Answer 19: Correct.
