QUESTIONS AND ANSWERS

Q1: Is it possible to have three separate manufacturers when quoting this? ie – the lounge area uses one manufacturer and use a different one for the kitchenette?

A1: Separate manufacturers can be used through a single supplier and award.

Q2: Will this project be awarded by subcategory or as a single award? If awarded by subcategory, could you please provide separate Delivery and Installation tables per subcategory?

A2: Single award.

Q3: Cat 6 Collaborative tables item 11 - will the Client also accept an end gable option?

A3: Yes, end gable is acceptable.

Q4: Cat 6 Kitchenette chairs item 30 - will the Client also respectively accept a sled base option? Given the application, its our strong belief a sled base provides the additional safety and stability for users who average between 275 and 300 lbs.
