Amendment 003 of Request For Proposal M7594-204766/A is raised to respond to questions received:

A. QUESTIONS & ANSWERS

- Q7. Regarding Shell Material I (Dark Navy) as per specification G.S. 1045-298 and Shell Material II (Fluorescent yellow-green) as per specification G.S. 1045-310, is there any recommendation which shell fabric suppliers can provide the materials?
- A7. It is the bidder's responsibility to source the required materials that meet the specifications. Please refer to Article 6.12.
- Q8. Annex "A" Requirement, "As and When Requested" - Stripe, Trousers Inclement for item 8 (Regular Sizes) and item 12 (Special sizes), it requests one Firm Unit Price for three items 5265, 5270, 5275, but they are different kinds of shell materials, can they quote the price individually?
- A8. It will remain a single unit price for the three items. Bidders must bid accordingly.
- Q9. In the tender, it does state that viewing samples and patterns are not available, however, it helps the accuracy of the tender if the bidders were able to have patterns to ensure reduced waste material. Is it possible to have any of the patterns or viewing samples?
- A9. Patterns and viewing samples will be provided to bidders when they are asked to provide PAS after bid closing. All bidders are treated equally in this regard. The RCMP cannot provide samples and patterns to all potential bidders. The distribution and return of these would be cumbersome.
