1) Respond to vendor’s questions.

1) VENDOR QUESTIONS

- Q16 -** Given that the content in these amendment responses require some adjustments in our bid, we would like to request that the Crown grant a 2 week extension to the current February 19, 2021 bid closing date?
- A16 -** Canada has considered your request. Please refer to Amendment 006, item 2, which has already extended the bid period by 1 week from February 19th, 2021 to the new closing date of February 26th, 2021. No further extensions will be granted.
- Q17 -** **Mandatory Corporate Reference M3, Amendment 006, Item 1) – This amendment adds ‘Analytics’ to the Application/Software Architect category. Given that ‘Application/Software Architect (Analytics)’ is not a valid category on TBIPS and, as per M3, if the category is the same then supporting evidence is not required. Will the Crown please confirm that if the same category is provided ‘Application/Software Architect’ under the reference contract that further evidence supporting the SOW baseline tasks is not required?**
- A17 -** For the purpose of Mandatory Corporate requirement M3 in Attachment 2, the resource category of "Application/Software Architect" will be considered as the same as "Application/Software Architect (Analytics)" and no further evidence supporting the SOW baseline tasks is required.
- Q18 -** **R1 states The Bidder should demonstrate that the proposed resource has experience over and above the experience demonstrated in M1. Can you clarify if we demonstrate 5 years in M1, can the same projects in M1 be counted in R1 for maximum points? or is it an additional 9+ years to max out the points?**
- A18 -** Regarding R1 requirements in Attachment 3.1 and the stated question: the same project(s) in M1 can be used to account for the additional experience in R1. As per the stated Points Allocation, the additional experience is above the 5 years in M1. The 9+ years is for the overall experience and not above the 5 years in M1.
- Q19 -** **Attachment 3.1 Resource Rated Requirements tables as issued in the RFP are formatted to request the Demonstrated Experience and Page # of Resume in separate columns.**
