#### A. Solicitation End Date

The closing date for tender 5P420-20-0373/A is extended from February 18, 2021 to **February 19, 2021** at 2:00PM Mountain Standard Time (MST).

### A. Question and Answers

- Q19) Are you expecting to have new flooring throughout, new flooring in rooms affected by wall demolition, or patch floors where demolition occurs?
- A19) Disturbed or exposed flooring from demolition is to be patched as per project brief.
- Q20) Is there a proposed layout and preferred building method (concrete or wood) for the required exterior access ramp to the new handicap access door?
- A20) Exterior ramp is not included in scope of work, only doors.
- Q21) Are you expecting a new ceiling in room 134 (Kitchen) or patch ceilings when walls are removed?

A21) Kitchen ceiling is to be patched to match existing

- Q22) Scope calls for new ceilings in various room numbers. Are these the new room numbers or original room numbers?
- A22) Ceiling reference numbers are as identified in new proposed layout.
- Q23) Please confirm size of existing HWT and indicate same size or larger tank required
- A23) Hot water tank is not part if project scope.
- Q24) Please confirm whether existing hot water tank is to be replaced?
- A24) See A23
- Q25) How many hot water tanks currently exist in building?
- A25) See A23
- Q26) Is hot water tank propane or electric?
- A26) Propane. See previous answer.
- Q27) Is there old mechanical drawing that we might have access to?
- A27) No additional reference documentation is available.
- Q28) Where are the main trucks for the existing forced air system?
- A28) Exact duct system layout is not known. Main delivery of forced air is below floors on both levels.
- Q29) Are we replacing the furnaces?
- A29) No.
- Q30) How many Furnaces is there in each furnace room? What areas do they supply?
- A30) There are 4 furnaces for the main mechanical room: 2 for main floor classrooms, 1 for activity area, 1 for upstairs. There are 2 furnaces in western portion of building mechanical room: One per floor.
- Q31) The only Return air grills we could see was a large grill in what looks like the mechanical room wall and transfer grills on the interior doors. Is there any other return air in the building?

Q36) Has there been a heat loss/gain calculation done for the building?
