Amendment 003

This amendment is raised to answer a bidder question, and make changes to the solicitation documents in response to the question clarification. The following are addressed:

- A) Question and Answer;
- B) Amend Annex A Statement of Work; and
- C) Amend Annex F Technical Evaluation.

A) Question and Answer

Q1. The cargo capacity for the RFP was changed to 63.4 cubic feet. I checked the Astar Flight manual this morning and I believe that the previous number mentioned was the correct one.

Cargo capacity for squirrel cheeks and tail boom cargo compartment are a total of 49.34 cubic feet. LH Side cheek 15.3, RH side cheek 14.1, rear cargo hold 19.94 for a total of 49.34.

A1. You are correct, the values used to calculate the change for item 6.1(c) under Solicitation Amendment 002 were incorrect.

Please note that the change under Amendment 002 to item 6.1 (c) of Annex A – Statement of Work for the total value of the closed baggage compartment volume was incorrect. The value should indicate 1.39 m³ (49.08 ft³). Parks Canada has amended the value of the requirement expressed in 6.1(c) to address this issue.

B) Amend Annex A – Statement of Work

Bidders <u>MUST</u> submit their bids in accordance with the changes to Annex A – Statement of Work included herein. Bids that are not submitted in accordance with this amendment will be deemed non-responsive to the solicitation requirements.

Under Annex A – Statement of Work section 6. Aircraft Requirements, delete item 6.1 (c) in its entirety and replace it with the following:
