#### Title: Pricing Insights Database

### 1. Advance Contract Award Notice (ACAN)

An ACAN is a public notice indicating to the supplier community that a department or agency intends to award a contract for goods, services or construction to a pre-identified supplier, thereby allowing other suppliers to signal their interest in bidding, by submitting a statement of capabilities. If no supplier submits, a statement of capabilities that meets the requirements set out in the ACAN, on or before the closing date stated in the ACAN, the contracting officer may then proceed with the award to the pre-identified supplier.

### 2. Definition of the Requirement

The Patented Medicine Prices Review Board (PMPRB) requires access to comprehensive Canadian national pharmacy data that reports by DIN, the price, the quantity and the number of prescriptions dispensed, as well as the payer type and province. The PMPRB requires this data in order to complete its analytical priorities and fulfill its reporting mandate. Some of the analytical priorities that make use of this data include Private Drug Plans in Canada and the Market Intelligence Reports.

### 3. Criteria for Assessment of the Statement of Capabilities

Any interested supplier must demonstrate by way of a statement of capabilities that it meets the following requirements:

• Annual delivery of comprehensive Canadian national pharmacy data that reports by DIN, the price, the quantity and the number of prescriptions dispensed, as well as the payer type (public, private, cash, NIHB) and province.

### 4. Justification for the Pre-Identified Supplier

The supplier mentioned in Section 9 below is the only known supplier that meets the mandatory criteria set out in Section 3 above.

Should Canada receive a statement of capabilities from a supplier that contains sufficient information to indicate that it meets the requirements set forth in this ACAN, a competitive process will be triggered with a technical and financial evaluation methodology of the bids proposed by the potential bidders.

## 5. Government Contracts Regulations Exception(s)

The following exception(s) to the Government Contracts Regulations is (are) invoked for this procurement under subsection Sub-section 6(d) - "only one person is capable of performing the work".

The identified supplier IQVIA Solutions Canada Incorporated is the only one able to meet all criteria identified in Section 3 above.

#### 6. Ownership of Intellectual Property

Ownership of any Foreground Intellectual Property arising out of the proposed contract will vest in the Contractor.

## 7. Period of the Proposed Contract or Delivery Date

The proposed contract is from contract award to March 31, 2025.

### 8. Cost Estimate of the Proposed Contract

The approximate cost of this requirement will not exceed \$39,529.43 (CAD) for the full term of the Contract. Customs duty included and Applicable Taxes extra.
