QUESTIONS AND ANSWERS

Question 31

Point Rated Criteria R6 for the Technology Architect (Legacy Systems), Level 3 requires resources to have more than 3 years of experience within the last 2 years to score full points, which is not possible. Would CBSA modify the requirement to read "The Bidder should demonstrate the proposed resource has experience, within the last seven (7) years prior to the solicitation issue date, forecasting..."?

Answer 31

Please refer to Solicitation Amendment 06 and the response to question 29.

Question 32

The Crown uses the following words: "... the proposed resource has experience, within the last two (2) years prior to the solicitation issue date ..." in the Rated Requirements for the following Technology Architect Resource Categories:

- Systems Engineer Lv3 (R1 to R5);
- Capacity Management Lv3 (R1 to R4);
- 2-Factor Authentication Lv3 (R1 to R5); and,
- Legacy Systems Lv3 (R1 to R6).

Could the Crown please clarify what is meant by "within the last two (2) years"? For example, does the Crown mean two years of experience within the last two (2) years? Or, any length of service within the last two (2) years? Or, a specific period of time within the last two (2) years?

We recommend that one (1) year within the last two (2) years would be sufficient and should be specified in the RFP as this would allow Bidders and CBSA to consider Resources that have all of the CBSA environment experience but may have left CBSA within the past year and are available to work again with CBSA.

Answer 32

For the referenced criteria, points are awarded for experience with each item, i.e. tools/technology, described in each criterion as per the Point Allocation Grid. The experience

should be within the past two years to ensure having recent experience. The requirement remains unchanged.
