## **SPECIAL INSTRUCTIONS TO BIDDERS (SI)**

### **SI01 BID DOCUMENTS**

1. The following are the Bid Documents:

Submission of a bid constitutes acknowledgement that the Bidder has read and agrees to be bound by these documents.

2. General Instructions - Construction Services - Bid Security Requirements R2710T is incorporated by reference and is set out in the Standard Acquisition Clauses and Conditions (SACC) Manual, issued by Public Works and Government Services Canada (PWGSC). ### **SI02 ENQUIRIES DURING THE SOLICITATION PERIOD**

1. Enquiries regarding this bid must be submitted in writing to the Contracting Authority named on the Invitation to Tender - Page 1 at e-mail address [Sheila.dhanna@pwgsc-tpsgc.gc.ca](mailto:Sheila.dhanna@pwgsc-tpsgc.gc.ca) Except for the approval of alternative materials as described in G115 of R2710T, enquiries should be received no later than 7 business days prior to the date set for solicitation closing to allow sufficient time to provide a response. Enquiries received after that time may result in an answer NOT being provided.
2. To ensure consistency and quality of the information provided to Bidders, PWGSC will examine the content of the enquiry and will decide whether to issue an amendment.
3. All enquiries and other communications related to this bid sent throughout the solicitation period must be directed ONLY to the Contracting Authority named in paragraph 1. above. Failure to comply with this requirement may result in the bid being declared non-compliant.

## **SI03 MANDATORY SITE VISIT**

### **MANDATORY SITE VISIT**

1. There will be a site visit on March 05, 2021 at 10:00AM. Interested bidders are to meet at Millhaven Institution Visitor registration building.

The site visit for this project is MANDATORY. Bids submitted by Bidders who did NOT attend the site visit and are not on the attendance sheet will be rejected. It is the Bidders responsibility to make sure their names are called at time of attendance.

#### **2. Safety Attire:**

In order to be guaranteed access to the site visit, all persons are required to wear proper personal protection equipment, safety boots, hard hats; Safety glasses and non-medical face mask/face covering.

3. NOTE: As a result of the COVID-19 pandemic, the following precautions are mandatory during the site visit:

#### **Personal Protective Equipment Required**

1. Safety Boots
2. Hard Hat
3. Safety glasses
4. Reflective vest (optional)
5. Non-medical masks/face covering
6. Attendees to supply their own hand sanitizer.

#### **Site Visit Plan**

- Only one bidder from each company permitted, to a maximum of 10 people including PSPC or other representatives.
- Bidders will meet at Millhaven Institution Visitor registration building?
- Departmental Representative will take attendance.
- Departmental Representative will lead bidders... allowing bidders to view the existing conditions.

#### **COVID-19 Precautions**

- Bidder self-screening and declaration that they are not ill is required at arrival (see attachment).
- Observe proper hand hygiene while on site. Sanitize hands before entering the building and after exiting
- Wear a Non-medical masks/face covering at all times while outside of vehicle.
- Maintain 2m social distancing at all time.
- Attendance will be taken by Bidders announcing their name and Departmental Representative recording (no list will be passed around).
- Avoid social greetings (e.g. shaking hands).

For the day of the site visit:

1. Contractors, consultants, and project team will be required to complete the CSC Covid-19 questionnaire. (attached)
2. All parties are to wear masks at all times. DO NOT INTERACT WITH INMATES OR STAFF, OTHER THAN STAFF ATTENDING THE SITE VISIT.
3. Two metre physical distancing will be maintained during the visit, the visit duration will be kept to a minimum.
4. Entry into the building is forbidden.
5. Contractors, consultants, and project team will meet at the Millhaven Institution Visitor registration building.
6. An attendance sheet will be completed, sanitising contact surfaces will be completed between each visitor.
7. PSPC PM will provide to CSC a copy of the PSPC Attendance/Sign sheet. (for contact tracing purposes)

Bidders must communicate with the Contracting Authority no later than three (3) days prior to the scheduled site visit to confirm attendance and provide the name(s) of the person(s) who will attend.

Bidders who do not attend the site visit or do not send a representative will not be given an alternative appointment.

#### **SI04 REVISION OF BID**

A bid may only be revised by epost Connect in accordance with GI10 of R2710T .

#### **SI05 BID SECURITY REQUIREMENTS**

R2710T - General Instructions - Construction Services - Bid Security Requirements is modified as follow:

Delete GI08 Bid Security Requirements and replace with the following:

1. The Bidder shall submit bid security with the bid in the form of a bid bond in an amount that is equal to not less than 10 percent of the bid amount. Applicable Taxes shall not be included when calculating the amount of any bid security that may be required. The maximum amount of bid security required with any bid is \$2,000,000.
2. A bid bond (form PWGSC-TPSGC 504) shall be in an approved form, properly completed, with valid and enforceable signatures and sealed by the approved bonding company whose bonds are acceptable to Canada either at the time of solicitation closing or as identified in Treasury Board Appendix L, Acceptable Bonding Companies.
- 2.1 A bid bond must be submitted in an electronic format (Electronic Bonding (E-Bond)) and must meet the following criteria:
  - a. The version submitted by the Bidder must be an electronic encrypted file with embedded digital certificate verifiable by Canada with respect to the totality and wholeness of the bond form, including: the content; all digital signatures; all digital seals; with the Surety Company, or an approved verification service provider of the Surety Company.
  - b. The version submitted must be viewable, printable and storable in standard electronic file formats compatible with Canada, and in a single file, allowable format pdf.
  - c. The verification may be conducted by Canada immediately or at any time during the life of the Bond and at the discretion of Canada.
  - d. The results of the verification must provide a clear, immediate and printable indication of pass or fail regarding Item 2.1.a.
  - e. Submitting copies (**non-original, non-verifiable or scanned copy**) of signed and sealed bid bond are not acceptable. Failure to submit an original or verifiable bond will render the bid non-compliant. Non-

compliant bids will be given no further consideration. A scanned copy of a bond does not constitute a digital bond.

2.2 Bonds failing the verification process will NOT be considered valid.

2.3 Bonds passing the verification process will be treated as original and authentic.

3. Bid security shall lapse as soon as practical following
- the solicitation closing date, for those Bidders submitting non-compliant bids; and
  - the administrative bid review, for those Bidders submitting compliant bids ranked fourth to last on the schedule of bids; and
  - the award of contract, for those Bidders submitting the second and third ranked bids; and
  - the receipt of contract security, for the successful Bidder; or
  - the cancellation of the solicitation, for all Bidders.
4. Notwithstanding the provisions of paragraph 8 of GI08 and provided more than three compliant bids have been received, if one or more of the bids ranked third to first is withdrawn or rejected for whatever reason then Canada reserves the right to hold the security of the next highest ranked compliant bid in order to retain the bid security of at least three valid and compliant bids.

## **SI06 SUBMISSION OF BID**

R2710T GI09 Submission of bid is modified as follows

1. The Bid and Acceptance Form, duly completed, and the bid security shall be submitted with the bid provided by the Bidder, and in accordance with the procedures set out in SI06.5 below. The bid must be received on or before the date and time set for solicitation closing.
2. Unless otherwise specified in the Special Instructions to Bidders the bid shall be in Canadian currency; the requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All bids including such provision will render the bid non-responsive.
3. Prior to submitting the bid, the Bidder shall ensure that the following information is clearly printed on the face of the bid:  
Solicitation Number;  
Name of Bidder;  
Return address; and  
Closing Date and Time.
4. Timely and correct delivery of bids is the sole responsibility of the Bidder.

### **5. Electronic Bid Submission by epost Connect service**

- a. Bids must be submitted by using the epost Connect service provided by Canada Post Corporation. Faxed and hard copy bids (submitted in person or via mail/courier) will not be accepted for the subject bid solicitation.

**Note:** Bids emailed directly to this email address will be rejected and deemed non-compliant. - c. To submit a bid using epost Connect service, the Bidder must either:

- i. send directly its bid only to the specified PWGSC Bid Receiving Unit, using its own licensing agreement for epost Connect provided by Canada Post Corporation; or
  - ii. send as early as possible, and in any case, at least six business days prior to the solicitation closing date and time, (in order to ensure a response), an email that includes the bid solicitation number to the specified PWGSC Bid Receiving Unit requesting to open an epost Connect conversation. Requests to open an epost Connect conversation received after that time may not be answered.
- d. If the Bidder sends an email requesting epost Connect service to the specified Bid Receiving Unit in the bid solicitation, an officer of the Bid Receiving Unit will then initiate an epost Connect conversation. The epost Connect conversation will create an email notification from Canada Post Corporation prompting the Bidder to access and action the message within the conversation. The Bidder will then be able to transmit its bid afterward at any time prior to the solicitation closing date and time.
  - e. If the Bidder is using its own licensing agreement to send its bid, the Bidder must keep the epost Connect conversation open until at least thirty (30) business days after the solicitation closing date and time.

  - i. The Bid Receiving Unit will send an acknowledgement of the receipt of bid document(s) via the epost Connect conversation, regardless of whether the conversation was initiated by the supplier using its own license or the Bid Receiving Unit. This acknowledgement will confirm only the receipt of bid document(s) and will not confirm if the attachments may be opened nor if the content is readable.
  - j. ## **SI08 INSUFFICIENT FUNDING**

In the event that the lowest compliant bid exceeds the amount of funding allocated for the Work, Canada in its sole discretion may

- a. cancel the solicitation; or
- b. obtain additional funding and award the Contract to the Bidder submitting the lowest compliant bid.

## **SI09 BID VALIDITY PERIOD**

1. Canada reserves the right to seek an extension to the bid validity period prescribed in BA04 of the Bid and Acceptance Form. Upon notification in writing from Canada, Bidders will have the option to either accept or reject the proposed extension.
2. If the extension referred to in paragraph 1. above is accepted, in writing, by all those who submitted bids, then Canada will continue immediately with the evaluation of the bids and its approvals processes.
3. If the extension referred to in paragraph 1. above is not accepted in writing by all those who submitted bids then Canada will, at its sole discretion, either
  - a. continue to evaluate the bids of those who have accepted the proposed extension and seek the necessary approvals; or
  - b. cancel the invitation to tender.
4. The provisions expressed herein do not in any manner limit Canada's rights in law or under GI11 of R2710T.

## **SI10 RIGHTS OF CANADA**

1. Canada reserves the right to:
  - a. Reject any or all bids received in response to the bid solicitation;
  - b. Enter into negotiations with bidders on any or all aspects of their bids;
  - c. Accept any bid in whole or in part without negotiations;
  - d. Cancel the bid solicitation at any time;
  - e. Reissue the bid solicitation;
  - f. If no compliant bids are received and the requirement is not substantially modified, reissue the bid solicitation by inviting only the bidders who bid to resubmit bids within a period designated by Canada; and
  - g. Negotiate with the sole compliant Bidder to ensure best value to Canada.

  - b. In respect to losses for which insurance is not required to be provided in accordance with the insurance requirements of the Contract, the greater of the Contract Amount or \$5,000,000, but in no event shall the sum be greater than \$20,000,000.
2. The limitation of this obligation shall be exclusive of interest and all legal costs and shall not apply to any infringement of intellectual property rights or any breach of warranty obligations.
  3. The Contractor's obligation to indemnify Canada for losses related to third party liability shall have no limitation and shall include the complete costs of defending any legal action by a third party. If requested by Canada, the Contractor shall defend Canada against any third party claims.
  4. The Contractor shall pay all royalties and patent fees required for the performance of the Contract and, at the Contractor's expense, shall defend all claims, actions or proceedings against Canada charging or claiming that the Work or any part thereof provided or furnished by the Contractor to Canada infringes any patent, industrial design, copyright trademark, trade secret or other proprietary right enforceable in Canada.
  5. Notice in writing of a claim shall be given within a reasonable time after the facts, upon which such claim is based, became known.
