Question 33:

Section 4.3 (c) "Financial Evaluation" is currently evaluating companies based on resources category rates with unequal weighting. Would Canada consider changing the financial evaluation method to reflect equal weighting of each resource category in the evaluation process?

Answer 33:

Canada has reviewed the request, however the weighting for the financial evaluation remains unchanged.

Question 34:

We hold multiple large contract agreements that require informatics professional services to be provided on an "as and when needed" basis through Task Authorizations. Would the Crown please confirm that Bidders may utilize Task Authorizations on such contracts to demonstrate experience in response to Rated Criteria R2, R3, R4, R5 and R6 provided that the components of each criteria are demonstrated?
