Amendment 005 is raised to a) publish questions and answers and b) Extend the closing date to March 3, 2021 (2021-03-03).

Q54. Q&A # 42 the GoCUID for CAT6C item 8 has changed to be a four-legged bar stool. As the option for a sled base was accepted in amendment 2 for items C1 & C2 and since this must be from the same series as C1 and C2, to confirm consistency in responses please confirm a sled base is still acceptable.

A54. : It was stated that sled base would also be accepted as an option for C1, C2 as long as it does not impede on the size of the chair stated in the additional product details, and C8 chairs to be from the same series. C8 chair with a sled base will also be accepted as an option.

Q55. With the recent change to Cat 6C, line 8, 6KBSCHxxLY15XXXPINX, adding armrests, would a change to the gocuid to include armrests for Line 1 6KBSBHxxLY15XXXRONX and Line 2 6KKCSAxxLY16XXXMONX be accepted? 6KKCSAxxLY16XXXMINX.

A55. Line item 8 product was originally stated for the chair to have arms. The only requirement that has changed is that it needs to be counter height. No, line item 1 and 2 will not require arms.
