QUESTION AND ANSWER

Question 1:

We have two psychologists in one province that use the Personality Assessment Inventory (PAI®) instead of the MMPI in their practice. Can criterion MT.6 (c) be amended to accommodate psychologists who do not use the MMPI but the PAI® instead? The psychologists meet MT.6 (b) but cannot demonstrate compliance with the MMPI in the past 36 months for criterion MT.6 (c).

Answer 1:

As per Attachment 1 to Part 4 – Technical Evaluation Criteria, section 1.2 Mandatory Technical Evaluation Criteria for Clinical Psychologists, criterion MT.6 (c): A minimum of 36 months (equivalent of three (3) years) of experience prior to the Bid Solicitation publication date, using the MMPI-2 or MMPI-2-RF in psychodiagnostic or clinical psychological suitability assessment is mandatory.

The requested experience does not have to be in the past 36 months. The phrase “36 months (equivalent to three (3) years) of experience prior to the Bid Solicitation publication date” refers to the total experience with this instrument and can have been acquired at any time in the psychologist’s career prior to the Bid Solicitation publication date.
