1. QUESTIONS AND ANSWERS:

Question 1

Can we request to extend the delivery date to 90 days after the contract award?

Answer 1

No, the delivery date is firm as March 31, 2021.

Question 2

Please see below two style mask in this solicitation and advise if you can accept both styles?



Answer 2

Elections Canada will accept either style of mask for the full quantity. The order cannot be split into two styles of masks.

Question 3

Is this an one time delivery order?

Answer 3

The quantity of 240,000 transparent masks is a one time delivery order, however, the optional additional quantity of up to an additional 50,000 transparent masks may be required.

Question 4

Can you accept imported goods from China?

Answer 4

As long as the transparent mask meets all mandatory specifications stipulated in Annex A and Request for Proposal.

Question 5

Can we make partial delivery for this order to meet the delivery timeline?

Answer 5

Yes, partial delivery is acceptable provided the full quantity of 240,000 transparent masks is received by March 31, 2021.
