**Questions and Answers**

**Q1.** Is construction and paving of the new Route 66 Alignment as indicated on the "New Fire Fighting Training Area Design" included in the New FFTA scope of work?

**A1.** The Route 66 alignment will be completed by others prior to this work. Paving is only required where utilities are relocated across the road, in accordance with the Contract.

**Q2.** Our bonding agency has submitted a e-bond and informed us that this can be printed off and submitted as a hardcopy. The e-bond has been affixed with the proper seals. Is this correct, or do all e-bonds need to be submitted digitally?

**A2.** e-Bonds will have to be submitted electronically. Once it's printed, we won't be able to verify it.

Submitting copies (**non-original or non-verifiable**) of signed and sealed bid bond are not acceptable. Failure to submit an original or verifiable bond will render the bid non-compliant. Non-compliant bids will be given no further consideration. A scanned copy of a bond does not constitute a digital bond.

If you are submitting a hardcopy bond, it will have need to have original 'wet' signatures and original seals. Please see SI06 Bid Security Requirements for more information.

**Q3.** Is an Agreement to Bond required with the bid submittal?
