Solicitation Amendment 003 is being raised to answer bidder questions, as follows:

Question 1: Would you be kind enough and clarifying the following Clause:

5.1.2.1 Canadian Content Certification.

Does the client want a product made in Canada or serviced in Canada?

The reason we were asking is because on clause:

5.1.2.1 Canadian Content Certification: **This procurement is conditionally limited to Canadian goods.**

Subject to the evaluation procedures contained in the bid solicitation, bidders acknowledge **that only bids with a certification that the good(s) offered are Canadian goods, as defined in clause A3050T, may be considered.**

But clause 1.3 Canadian Content: **The requirement is subject to a preference for Canadian goods.**

So we not sure if we send in something that is not made in Canada will it be taken into consideration.

Answer 1: As per para 1.3 Canadian Content, the requirement is subject to a **preference** for Canadian Goods.

A Canadian Good is defined in clause [A3050T](#) of the SACC Manual.

As per Para 5.1.2.1 Canadian Content Certification, this procurement is **conditionally limited** to Canadian goods.

“Conditionally limited” means: **if two or more bids offer Canadian goods, other bids will not be considered.** Hence the preference for Canadian goods.

Bidders should note that, as per 5.1.2.1 Canadian Content Certification, failure to provide this certification completed with the bid will result in the good(s) offered being treated as non-Canadian goods.

Question 2: If the certificate is not complete will the Bid be non responsive?

Answer 2: No.

All other terms and conditions remain unchanged.
