QUESTIONS AND ANSWERS

Q9: Will you also accept separate BIDs by sub-categories as to allow for more competition?

A10: No, all subcategories should come from a single supplier.

Q10: For GoCUID 6KBSCHxxSY15XXXPOYX, Item 31, Will you also accept stool with 4-legs, GoCUID 6KBSCHxxLY15XXXPOYX? The other chairs in this requirement are 4-leg versions and this would more likely ensure continuity of design.

A10: Yes, 4-leg stool is also acceptable.

Q11: Different suppliers can offer different types of products. To allow for more compliant bids and increased competition, would you allow the following products to be separated onto a sub-category on its own:

Multi-media Tables:

A11: No. The solicitation will remain as is.

Q12: There is an oversite it seems with the technical SA specifications for Private Lounge chairs. While they have allowed the end-user to select a GOCUID for either a) tablet or b) work surface with two different GoCuids, however, there is no technical specification as to what constitutes a "Tablet" and what constitutes a "worksurface" other than nomenclature. The description is simply listed as "and/or" in the technical spec found on page 73 of the technical guide. Seeing as there is no technical spec against which to check for compliance, can you please confirm that for Item on line 35 or Category 6 - Open Area Workspace, that a "Surface" provided, as long as it can support a laptop, is integrated into the unit, and is oriented in front of the user as defined Technical guide will be accepted regardless of what the manufacture calls the surface? Perhaps changing the Answer for Q6 in Amendment 1?

A12: Any items meeting the technical specification will be accepted.

Q13: Regarding the security requirement of Solicitation No. 202104574C, we have a question about "a valid VOD clearance number issued by CISD", what is CISD? Would an Ontario Public Service (OPS) Contractors Security Clearance issued by MGCS(Ministry of Government and Consumer Services) be acceptable?

A13: CISD is the acronym for Canadian Industrial Security Directorate. No will not accept Ontario Public Services (OPS) Contractors Security Clearance.



Q14: Can you provide drawings for the items requested on this solicitation? A14: Drawings will be provided prior to installation to the successful bidder.

Q15: Can you please confirm that any product received prior to March 31st will be temporarily stored in a RCMP storage facility and any product that cannot be received by March 31st will need to be delivered directly to 73 Leikin in mid-October?
