


This is what the shelf depth is 15 inches and on the other side is another shelf that is 15 inches.

Question 2:

Can you please provide the brand and model of the existing electronic mobile carriages to be replaced and also for the electronic carriages switching to mechanical assist?

Line item 2.1.1.a.i states, "3 feet in length with side and top structure". If the shelving is to be 3 feet in length with 15 columns per bay, are the carriages not 45' in length rather than 48'?

Response 2:

The system in use is space saver, the bays are 45 feet in length

Question 3:

Could you please clarify if you're referring to bays and carriages as one in the same? Also, please provide a breakdown of the 11 bays of shelving to be replaced, in terms of double and single entry shelving units? i.e. 5 double entry carriages and 1 single entry carriage = 11 bays of shelving or 11 double entry carriages = 11 bays of shelving. Alternatively could you please provide a breakdown of the 990 shelves required in terms of double and single entry depth?

Response 3:

There is one shelf on either side of the bay in all cases. Please refer to the pictures above in question one (1)

Questions 4:

What is the height and depth of the existing shelving units not including carriages?

Response 4:

The shelves are 7 feet 1 inch from the floor, the inch is clearance. The shelves are 15 inches deep - one shelf on each side of the bay for 30 inches in total.

Question 5:

Are new laminate end panels required on the carriages being changed from electronic to manual assist or can we retrofit the existing?

Response 5:

The panels are old, but if it is possible to retrofit them, yes RCMP would allow this.

Question 6:

Will the contents of the shelving be removed prior to the work?

Response 6:

Yes, if it can be done in sections that would work best for us, but we will come up with a plan to remove all of them if that is needed.

Question 7:

Are the 6 carriages that will receive new electronic components included in the 11 bays that are getting new shelving?

Response 7:

Yes

Question 8:

Compliance Matrix #3 states, "Each 4 post shelf must come with a maximum of six dividers". Shouldn't this read a minimum of 6 dividers or would 2 dividers per shelf be acceptable?

Response 8:

RCMP will accept up to 6 dividers per shelf.

2.1.1 Tasks

1. Replace all cantilever shelving with static shelving (4 post):
 - a. 990 shelves: 6 shelves per column, 15 columns per bay, 11 bays
 - i. 3 feet in length with side and top structure
 - ii. 4,950 file dividers: 5 file dividers per shelf (one on each end and 3 in between), 6 shelves per column, 15 columns per bay, 11 bays
 - iii. 44 assistance/reference shelves (little pullout shelves to hold files when filing), 4 pullout shelves per bay, 11 bays
 - iv. Weight capacity – 100 lbs
2. Replace 2 electronic carriages on the 24 foot bays with manual assist carriages:
3. Replace the electronic system on the 6 electronic **assist 45 foot long** bays :
 - a. Motors
 - b. Logic board(s)
 - c. Electronic control pads
 - d. Security features, i.e sensors between the electronic mobile bays
4. Removal and disposal of all old parts.
5. All parts/hardware must come with a minimum of a 36 month warranty.
