This amendment is issued to provide answers to questions received from suppliers.

Questions and Answers

Question 1:

In December 2020, we provided a written response and demonstration in response to the PWGSC RFI #M7594-212120/A – National Digital Evidence Management System (DEMS) and Body Worn Cameras (BWC). Has the responses provided within this RFI response to PWGSC and RCMP been set aside?

Answer 1:

No. Canada is currently reviewing the information submitted by industry in response to RFI #1. As stated in RFI#2 (M7594-212120/B), responses and feedback received in response to RFI #1 (M7594-212120/A) will be summarized in a Summary of Feedback and Outcomes Report and published on BuyandSell.gc.ca at a later date.

Question 2:

Were the respondents of the RFI #M7594-212120/A to be notified of the publication of RFI #2? We did not receive any notification from PWGSC regarding RFI #2 even though we are registered.

Answer 2:

RFI #2 was published on BuyandSell.gc.ca to notify industry as a whole. It was not directed to the respondents of RFI#1 only. Question 3:

Answer 3:

RFI#2 is seeking additional feedback on a managed service approach for BWC and DEMS, costing methodologies and Basis of Payment structure, provision of services from Indigenous businesses, security considerations, accessibility requirements and other relevant questions. The RFI also contains additional questions raised during different one-on-one sessions so that all suppliers have a chance to provide inputs to the questions.

Question 4:

Is there a quantity of body cameras that the PWGSC is considering for the “managed service approach for BWC”?

Answer 4:

As indicated in RFI#1, the RCMP is working toward the goal of rolling out more than 10,000 body worn cameras nationally. The final quantity will be specified in a later phase of the procurement process.

Question 5:

Is it the intent to outfit just law enforcement officer or all staff with a body camera?

Answer 5:

The RCMP does not intend to equip its full staff. As a starting point, the RCMP intends to outfit its front-line police officers with body worn cameras.
