- 2. Modify 6.5.4 After-Sales Service.

QUESTIONS AND ANSWERS:

Answer 06	See answer to question 5 for additional details.
	We would like to suggest using extended life coolant from a particular manufacturer: 6000 hours or 3 years minimum, after 3 years the coolant can be checked and only an additive adjustment may be necessary. This is a gesture for the environment. All engine manufacturers have this type of coolant to limit the use of hazardous products.
Question 06	As specified in point 4.2.3 Initial parts kit 1. Do we have to supply hydraulic fluids, gears and coolant? 2. How many hours of use do you estimate? 200 or 500? 3. For spare parts, should we include wearing parts? Skates, edge blade, fan blades?
	See answer to question 6 for more details.
	The initial parts kit includes all the parts that need to be changed preventively after a number of hours of use or a given period of time according to the recommendations of the manufacturer's maintenance manual. This does NOT include fluids and liquids. This does NOT include wearing parts which depend on the severity of the particular operating conditions. Normally this kit contains almost exclusively filters and filter elements and occasionally may contain belts etc., according to the manufacturer's service manual. In order to validate the list, DND will consult the maintenance manual or the maintenance schedule recommended by the manufacturer.
Answer 05	As described at Annex A Para 4.2.3, each initial parts kit must include the parts required to perform preventive maintenance on one snow blower for a period of one year in accordance with the maintenance manual for each configuration/model. This includes a complete change of all filters and filter elements.
Question 05	As specified in point 4.2.3 - Initial parts kit, this approval must be done before the solicitation closes. The contractor must know exactly what parts will be required by the client and not afterwards, there is too much variable.
Answer 04	DND does not consider the two "designs" to have the same performance and capability hence as per Annex A Para 3.4 (a) a dual auger snow blower is required. Furthermore, there is more than two known OEMs able to manufacture equipment that meets the technical requirement of this solicitation.
Question 04	According to item 3.4 (a), a dual auger snow blower is required. Our standard snow blowers are dual helical ribbons. 1 left hand and 1 right hand helical ribbon. This item limits the bidders to Larue and RPM Tech. As you may know, these two, are just two different designs (dual helical ribbons and dual auger) with same operation capability and same lifetime.

	 The starter kit does NOT contain fluids. The hours of use to be estimated are according to the warranty request, ie 500 hours. Wear parts such as skates, edge blade, fan blades, which depend on the conditions of use, are NOT required in the kit unless the manufacturer recommends that these items be replaced preventively based on the hours of use or a fixed period of time of less than one year regardless of the conditions of use. Thank you for the proposal for a manufacturer specific (proprietary) extended life coolant. Given the current DND concept of operation, maintenance and supply chain for this equipment, it is undesirable to have proprietary lubricants and fluids in this equipment. Note that the French translation of Annex A Para 3.11 (a) is not faithful to the English version which requires fluids and lubricants to be "non-proprietary" and the French version will be amended for this procurement. We thank you for your suggestion and we will consider how we can implement this for future procurements.
Question 07	We meet the requirement at 100% except at item 6.5.4 After sales Service (Hall Beach NU) page 18 of 25. We do not have a dealer in that area so I would like to know from DND what is expected from our company regarding this issue. If successful, we would supply any parts required under warranty plus any/all information needed to address the issue.
Answer 07	There is a mistake at Article 6.5.4 of the RFP. It should have indicated the equipment delivery location which is 'CFB North Bay, ON'. Warranty/after sales service is expected to be provided close to the delivery location which in the current case is CFB North Bay. In such cases where DND moves the equipment and cannot bring back the equipment to the delivery location for warranty repairs, it is normal process that DND would only request parts and/or technical information necessary to complete
