#### Bulk Aviation Turbine Fuel, Mobile Tanker Rental, Driver and Refuelling Operator for Parks Canada's Western National Parks

##### **1. Background**

Parks Canada's Western National Parks purchase aviation fuel annually for helicopters used in fire management operations. Bulk helicopter fuel may also occasionally be required to support other types of incident response and management.

Quantities of aviation fuel required annually vary with the severity of the fire season. Fuel in rented mobile tanks is purchased as required for wildfires, prescribed fires, or to increase preparedness during periods of extreme fire danger. Fuelling operators are also usually required to accompany this requirement. Drivers are required for delivery and occasional redeployment of fuel tankers.

This Standing Offer will be in effect from the date of Standing Offer, to April 30, 2023, plus a one-year extension option from May 1, 2023 to April 30, 2024.

All prices are set out in Annex "B", Basis of Payment. Unit Prices for fuel are subject to upward or downward adjustment using the appropriate reference marker price applicable on the Friday just prior to the fuel delivery.

##### **2. Requirement**

###### **2.1 Aviation Turbine Fuel (Jet A-1) in a Mobile Tanker with or without Refuelling Operator**

- i. One or more mobile fuel tankers containing Jet-A-1 Aviation Turbine Fuel may be required;
- ii. The minimum required fuel capacity of the tanker is 17,000 litres;
- iii. Fuel is to be in accordance with Standard CAN/CGSB 3.23-2020 (or latest issue);
- iv. A daily rate will be paid for the mobile tanker rental;
- v. Transportation fees for transport of the mobile tank(s) and/or delivering additional fuel to the delivery locations are to be paid in accordance with Annex B, 7. Tanker Transportation to Park Gate and Annex B, 8. Per Kilometer Tanker Transportation Fees Beyond Park Gate.

###### **2.2 Transportation Fees**

Transportation Fees are to be expressed as:

- i. A firm rate for the distance to each park gate;
- ii. A per kilometre rate for the distance past each park gate.

###### **2.3 Refuelling Operator(s)**

One or more refuelling operators will be required for most call-ups against this standing offer.

- i. Fuelling operators shall be called up on an as-needed basis;
- ii. Requirement of none, one (1) or two (2) refuelling operators will be determined at the time of each call-up against standing offer;
- iii. Rates for refuelling operators are to be expressed as a day rate;
- iv. Parks Canada work / rest guidelines limit working days to 14 hours per day;
- v. Working hours may be extended beyond 14 hours during challenging scenarios where human life or infrastructure is considered at imminent risk;

- vi. Fuelling operators must be available during all daylight hours or for a time period in accordance with the daily standby alert established by Parks Canada.

#### 2.4 Mobile Tanker Driver

Mobile tanker delivery drivers are not usually required to remain at the tanker delivery site for daily operations. Drivers may be required to redeploy mobile tankers within parks depending on operational priorities.

- i. Driver services for original delivery of fuel is to be included in the rate expressed at Annex B, 7. Tanker Transportation to Park Gate and Annex B, 8. Per Kilometer Tanker Transportation Fee Beyond Park Gate;
- ii. Driver services for refuelling of a Mobile Tanker already in place is to be included in the rate expressed B, 7. Tanker Transportation to Park Gate and Annex B, 8. Per Kilometer Tanker Transportation Fees Beyond Park Gate;
- iii. Rates for drivers who are requested to remain on site are to be expressed as a day rate in accordance with Annex B, 10. Tank Driver;
- iv. As per Annex A, 2.6, when meals and accommodations are provided to the driver by Parks Canada, the contractor may not invoice Parks Canada for those items.

#### 2.5 Training

The driver(s) and operator(s) shall be trained:

- i. To meet CSA standard B836-14, the storage, handling and dispensing of aviation fuel at aerodromes;
- ii. to inspect the unit and aviation fuel testing as per CSA standard B836-14;
- iii. to meet the requirements of the Canadian Labor Code, transportation of dangerous goods and Workplace Hazardous Materials Information System (WHMIS);
- iv. Fuelling operators must be prepared and trained for hot-fuelling operations.

#### 2.6 Accommodations and Meals

An incident command structure following the Incident Command System (ICS) is in place most times Parks Canada is at the point of requiring mobile tank helicopter fuel. Under ICS, a logistics section is tasked with procuring accommodations for most incident personnel.

- i. Parks Canada may supply accommodations and meals to fuelling operators when logistical support is activated;
- ii. The contractor may not invoice Parks Canada for accommodations or meals when these are provided by Parks Canada;
- iii. The contractor may invoice Parks Canada for meals as per the Treasury Board Travel Directive rate when they are not provided by Parks Canada;
- iv. When Parks Canada does not provide accommodations, the contractor may invoice Parks Canada for accommodations on an at-cost basis, upon provision of receipt, without allowance for profit;
- v. The contractor must receive approval from the designated Parks Canada representative (most often the Logistics Section Chief) prior to procuring accommodations which will be invoiced back to Parks Canada.

### **3. Specifications**

Where standards are listed below and have been updated since the development of this Statement of Work, the most recent version of the standard shall apply.

#### **Mobile Tanker Specifications:**

- i. A minimum capacity of 17,000 litres and a maximum of 45,000 litres;
- ii. Compliance with CAN/ULC -S653-06: Aboveground Steel Contained Tank Assemblies for Flammable and Combustible Liquids;
- iii. Compliance with TC 406 of CSA-B620-14: Highway tanks and TC portable tanks for the transportation of dangerous goods;
- iv. Auto shutoff for overfill protection;
- v. Spill kit included;
- vi. Provisions to ensure proper bonding of each tank vehicle unloading position;
- vii. Minimum 100ft fuel hose, and associated coupling assemblies, that meet the requirements of API/IP Std 1529; TC portable tanks for the transportation of dangerous goods, CSA B836-14 Storage, handling and dispensing of aviation fuels at aerodromes;

#### **Fuel Pump Specifications:**

- i. Compliance with CSA-B836-14: Storage, handling, and dispensing of aviation fuels at aerodromes;
- ii. Fuel Meter System;
- iii. Electric Rewind Hose Reel with Aviation Grade Hose;
- iv. Emergency Shutoff Control;
- v. Filtration to effectively remove water, solids, or both from aviation fuel shall be provided, as required, to achieve an acceptable level of fuel cleanliness in the system.

#### **Refuelling Operator Requirements:**

- i. Compliance with CSA-B836-14: Fuelling equipment used for the receipt, storage, and dispensing of aviation fuel shall be operated only by personnel trained in accordance with Clause 8 of CSA-B836-14.
- ii. Fuel quality testing as per CSA-B836-14.

### **4. Return of Unused (and tested) Fuel for Credit**

The amount of fuel that will be required is extremely variable due to weather conditions over the fire season. It is required that the Contractor allows for the return of unused fuel for credit after it has been tested and deemed safe and usable.

### **5. Tasks**

- i. As and when requested, the Contractor will provide, a mobile tank containing fuel with or without an operator, a tanker driver, as well as all other support apparatus (such as pumps, meters, filters, hoses, nozzles, grounding, testing, spill containment, etc.) necessary to provide the Services;

- ii. As and When Requested, the refuelling operator must be available to provide the Services during all daylight hours or for a time period in accordance with the daily standby alert established by Parks Canada;
- iii. All personnel provided by the Contractor shall be equipped with the necessary Personal Protective Equipment including but not limited to:
  - a. Fire resistant clothing (coveralls or two piece);
  - b. Steel toed leather or rubber boots;
  - c. Supplementary hearing protection for worksites with noise levels 85db or greater;
  - d. Supplementary eye protection.
- iv. During the Standing Offer Period, the Contractor must:
  - a. Transport and deliver Aviation Fuel in a mobile tank to one or more of the following Parks within 24 hours of a request made by the Project Authority or Identified User Representative:
    - Kootenay National Park (British Columbia)
    - Yoho National Park (British Columbia)
    - Mount Revelstoke and Glacier National Parks (British Columbia)
    - Jasper National Park (Alberta)
    - Banff National Park (Alberta)
    - Waterton Lakes National Park (Alberta)
    - Elk Island National Park (Alberta)
    - Prince Albert National Park (Saskatchewan)
    - Riding Mountain National Park (Manitoba)
    - Wood Buffalo National Park (NWT and Alberta)
  - b. Provide for the relocation of the mobile tank within any of the above Parks within 12 hours of a request made by the Project Authority or Identified User Representative;
  - c. Establish safe into plane fuelling systems and environmental safeguards;
  - d. Have a filtration system that assures all Aviation Fuel product meets or exceeds the accepted quality standards for particulate and absorbed water;
  - e. Provide regular testing to ensure Aviation Fuel quality;
  - f. Provide all necessary equipment, personnel and Aviation Fuel to maintain operations over an extended period;
  - g. Set up, breakdown and tidy up the pump, hose, filters, grounding system and spill prevention equipment used at the site to provide the Services;
  - h. Supply qualified operators trained in accordance with all Contractor, provincial and federal standards;
  - i. Supply the necessary equipment and resources to meet all requirements as detailed in all applicable federal and provincial acts and regulations, including for example, The Transportation of Dangerous Goods Act, Environment Act, and applicable Fire Codes.

#### **6. Reporting**

On a quarterly basis, the Consumption Report, Annex "D" must be completed and forwarded to the Standing Offer Authority.

#### **7. Address details for the deliveries**

Delivery locations within each park will vary depending on the location of the heli-base or staging area. The contractor will be notified of delivery location within the park at time of call-up.

#### 1. Aviation Turbine Fuel (Jet A-1) – Bulk

1.1 In consideration of the Contractor satisfactorily completing all of its obligations under the Contract, the Contractor will be paid a firm unit price per litre for fuel, as specified below. Customs duties are included and Applicable taxes are extra.

Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work, unless they have been approved, in writing, by the Standing Offer Authority before their incorporation into the Work.

1.2 Firm unit prices per litre as shown below are subject to adjustment using Reference Markers “USGC” or “LA Pipeline”, as detailed at the clause entitled "Basis for Unit Price Adjustment" below.

1.3 For invoicing purposes the firm unit price per litre effective on the date of delivery will apply.

1.4 The firm unit prices per litre shown at Annex "B" *exclude* all taxes or levies that may be or are imposed on the sale of the product pursuant to any federal or provincial statute or regulation or territorial ordinance. However, where the Offeror is required by federal or provincial statute or regulation or territorial ordinance to collect from Canada, taxes or levies as a result of the sale of the product to Canada, except as otherwise provided in the Standing Offer, Canada will pay to the Offeror an amount equal to such tax or levy where applicable and substantiated by invoice.

#### 2. REVISION OF REFERENCE MARKER

In the event that:

- a) the applicable Reference Marker is discontinued; or,
- b) Public Works and Government Services Canada determines that the Reference Marker does not reflect market conditions;

the parties shall mutually agree upon an appropriate and comparable substitute and the Standing Offer shall be modified to reflect such substitute on a mutually agreed upon date.

#### **5. Method of Calculating Unit Price Adjustments**

Firm unit prices shown herein shall be subject to upward or downward adjustments based on the week ending just prior to fuel delivery, as detailed below.

##### **5.1 Price Adjustment Effective Day:**

The unit prices offered are based on the **February 26, 2021** posting as provided by the "USGC" or "LA PIPELINE" Reference Marker.

**5.1.1** An adjustment to the firm unit prices per litre will be calculated as indicated hereunder:
