This amendment is raised to publish questions and answers.

1. Publish questions and answers

Question 48: This contract has noted concerns about delivery timelines, and potential penalties for the contractor if they don't meet them. When reviewing the SOW DID's which outline all of the timelines for dates of first and subsequent submissions, there are no turnaround times specified for CCG. When the contractor submits documentation, they are subject to these timelines, however if the client is not subjected to any response timelines, it is impossible for the contractor to be held liable for the delivery timelines. Please clarify the Canada's responsibility (ie. Number of days) to respond to each of the submissions outlined in the SOW.

Response 48: The CCG is committed to making every effort to review DID submissions in a timely manner in order to prevent delays in delivery timelines, however, the number of days required to review DIDs is dependent on the complexity of the DID as well as the thoroughness of the submission. Vendors will not be held responsible for any delays on the part of CCG.
