This amendment is raised to provide answers to questions raised by potential bidders.

Question 39:

Regarding M2 and R1, would the Crown allow for a resource who worked under the identical TBIPS category, but at an inferior level, to be used to demonstrate compliance with those two criterion if the Bidder can demonstrate that the named resource had the corresponding minimum years' experience as required by the Level for which the billable days are being claimed, at the beginning of contract. This could be demonstrated by the Bidder through the submission of a Curriculum Vitae for the named resource highlighting their relevant experience up to the contract start date.

Answer 39:

Canada has reviewed the request, however the requirement remains unchanged. Level 1 experience does not satisfy the requirement for level 2 experience.

Question 40:

In reference to Appendix B to Attachment 4.1 (Response Form). Under Section 1: Client Information, Bidders are asked to provide a fax number for the named client contact. Many clients no longer use fax machines and have opted to email. Could the Crown please remove this requirement from Appendix B to Attachment 4.1 (Response Form) or indicate that it is an optional criteria.
