PART 1 - GENERAL INFORMATION

1.1 Statement of Requirement

CDSB (Canadian Division Support Base) Detachment, Wainwright requires a vehicle mounted diesel exhaust system that reduces and/or eliminates the amount of carcinogens released from the vehicle upon start up when in the vehicle bays without the need for infrastructure alterations. As well, the automatic design ensures that the AARFFVs are always ready to go, with no hoses or other attachments needed that could ultimately delay the deployment on emergency calls.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

2.2 Submission of Bids

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

It is the Bidder's responsibility to ensure the request for opening an epost Connect conversation is sent to the email address above at least six days before the solicitation closing date.

Faxed bids will be accepted at 1-418-566-6167.

Hard copy (submitted in person or via mail/courier) bids will not be accepted for the subject bid solicitation.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in AB.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.

STATEMENT OF REQUIREMENT

VEHICLE-MOUNTED DIESEL EXHAUST SYSTEMS

1. BACKGROUND

- 1.1 CDSB (Canadian Division Support Base) Detachment Wainwright Fire Hall has a fleet of three Aircraft Rescue Fire Fighting Vehicles (ARFFV) of varying vintage that require an after-market retrofit of exhaust systems in order to comply with Canada Labour Code, Section 125.1. It has been mandated that all new firefighting vehicles be supplied with this system at the time of purchase. The retrofitting of current models to meet the specifications for retrofit has been considered in accordance with the Canada Labour Code and has become the responsibility of each Base across Canada. Due to the imminent health risks associated with not having an approved exhaust system installed on our vehicles, a one-time contract is required at this time in order to quickly adapt as many of our fleet as possible. CDSB Detachment Wainwright currently has one vehicle fitted with an after-market filtering system as part of a test/pilot and has deemed the retrofit a success. The current model that is being used is a Ward No Smoke system.
- 1.2 CDSB requires a vehicle mounted diesel exhaust system that reduces the need for scheduled filter changes which in turn results in less maintenance downtime on the emergency vehicles. As well, the automatic design ensures that the AARFFVs are always ready to go, with no hoses or other attachments needed that could ultimately delay the deployment on emergency calls.

2. REQUIREMENT

- 2.1 The following describes the requirement for the supply of three vehicle-mounted diesel exhaust systems, a direct source capture system.
- 2.2 **Optional Purchase for onsite installation** - On-site installation, on existing Aircraft Rescue Fire Fighting Vehicles (ARFFV).

Please note: The optional purchase can be exercised anytime within one year after contract award. The contractor will be paid using the price quote as outlined in Annex B, "Basis of Payment". The option may only be exercised by the Contracting Authority, and will be evidenced for administrative purposes only, through a contract amendment.
